

MINUTES OF THE BOARD OF COUNTY COMMISSIONERS, BUNCOMBE COUNTY
NORTH CAROLINA, HELD MONDAY, AUGUST 7, 1961, at 10:00 A.M.

BE IT REMEMBERED: That the Board of County Commissioners of Buncombe County, North Carolina, met in a regular session Monday, August 7, 1961, at 10:00 o'clock A.M. in the Council Chamber of the Buncombe County Courthouse, Asheville, North Carolina, where and when the following business was transacted.

The meeting was called to order by the Chairman and upon roll call by the Clerk, it was ascertained that the following members were present:

RESOLUTION REQUESTING THE BOARD OF COUNTY COMMISSIONERS OF BUNCOMBE
COUNTY TO CREATE A METROPOLITAN SEWER DISTRICT TO INCLUDE THE TOWN
OF BLACK MOUNTAIN

WHEREAS, in order to promote the health, safety and general welfare of the inhabitants of the Town of Black Mountain, and to adequately dispose of domestic sewage and industrial wastes within the corporate limits of the Town of Black Mountain as established under Chapter 747 of the 1951 Session Laws, it is necessary that a Metropolitan Sewerage District be created; and

WHEREAS, the procedure for the creation of such district is established by House Bill 796, entitled "A BILL TO BE ENTITLED AN ACT TO PROVIDE FOR THE CREATION AND ENLARGEMENT OF METROPOLITAN SEWERAGE DISTRICTS AND FOR THE ISSUANCE THEREBY OF GENERAL OBLIGATION BONDS AND REVENUE BONDS", passed by the 1961 General Assembly;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE TOWN OF BLACK MOUNTAIN:

That the Board of County Commissioners of Buncombe County be and it is hereby requested to create a Metropolitan Sewerage District under the authorization cited above to include the corporate limits of the Town of Black Mountain as established under Chapter 747 of the 1951 Session Laws.
