MINUTES OF METROPOLITAN SEWERAGE DISTRICT BOARD

PROGRESS REPORT BY MR. WALKER

The meeting of the Metropolitan Sewerage District Board was held in the Board Room 501, City Building, Asheville, North Carolina at 2:00 p. m. on Tuesday, February 19, 1963.

The meeting was called to order by the Chairman, Mr. M. C. Peterson. Mrs. Swicegood, Secretary, called the roll with the following members being present: Mr. Peterson, Mrs. Swicegood, Mr. Dawson, Mr. Finch, Mr. Garrison, Mr. Reagan, Mr. Robinson, and Mr. Tandy.

Upon motion of Mr. Dawson, reading of the minutes was dispensed with and they were approved.

Mr. Walker, Resident Engineer, gave a progress report in which he stated that drilling at the proposed main plant site was progressing sporadically, due to weather conditions and poor equipment. However, he estimated completion of this phase of the work in a few more days. He also stated that he was well pleased with the small degree of rock encountered in the area. The Swannanoa survey is scheduled to commence Monday, February 25, 1963, weather permitting.

Miss Carraway, Office Manager, gave a brief report on a talk she had with Mr. Warren J. Wicker, Assistant Director of the Institute of Government, Chapel Hill, North Carolina, regarding our Metropolitan Sewerage District.

Mr. Peterson acknowledged Mr. Philip Clark as having been assigned to report meetings of the Metropolitan Sewerage District Board for the Asheville Citizen. He also welcomed Mr. Reagan, Mr. Robinson, and Mrs. Swicegood as recent reappointees to full three-year terms as members.

There was some discussion with reference to bonds and methods of handling this phase of development, but no action was taken.

There being no further business the meeting adjourned at 2:30 p. m.
