MINUTES OF THE METROPOLITAN SEWERAGE DISTRICT BOARD

RESOLUTION RE: TRANSFER OF \$93,000 FROM RESERVE TO REDEMPTION ACCOUNT ADOPTED. RESOLUTION RE: CRESCENT HILL SEWAGE TREATMENT PLANT BIDS ADOPTED. GERBER SURCHARGE AGAIN DISCUSSED.

The regular monthly meeting of the Metropolitan Sewerage District Board was held in the Board Room 501, City Building, Asheville, North Carolina at 2:00 p. m. on Tuesday, July 21, 1970.

Vice Chairman Garrison, in the absence of Chairman Peterson, called the meeting to order and Mrs. Swicegood, Secretary, called the roll with the following members present: Mr. Garrison, Mrs. Swicegood, Mr. Dawson, Mr. Liles, and Mr. Williams.

The members having received copies of the previous minutes, Mr. Dawson moved and Mr. Williams seconded the motion that they be approved as recorded. This motion was carried unanimously.

Mr. Johnson, Engineer-Manager, read a letter from the Trustee regarding the transfer of \$93,000 in the Reserve Account to the Redemption Account, and for a Resolution adopted by the Board authorizing this transfer.

RESOLUTION

WHEREAS, the Trustee has informed the Metropolitan Sewerage District
Board that on August 15, 1970 he will have a surplus of \$93,000 in the Reserve Account
and has recommended this be transferred to the Redemption Account, and

WHEREAS, the Consulting Engineer and the Engineer-Manager concur in this recommendation

THEREFORE, BE IT RESOLVED that the Trustee be instructed to make the forementioned transfer and to immediately redeem outstanding bonds with these funds.

Mr. Dawson moved the resolution be adopted and Mr. Williams seconded the motion. The roll call vote was unanimous.

Mr. Johnson reported on the Crescent Hill bid opening held on July 17, 1970 and a summary of the bid proposals was read. The following resolution was read:

RESOLUTION

WHEREAS, after due notice in advertising sealed bids for the construction of Crescent Hill Sewage Treatment Plant were opened at 11:00 a.m. on July 17, 1970, and WHEREAS, three acceptable bids were received for the general contract and three acceptable bids for the plumbing contract attached, and

WHEREAS, less than three were received for the electrical contract,
THEREFORE, BE IT RESOLVED, that subject to approval by both the State and
Federal Agencies, that the general contract and plumbing contract be awarded to the
low bidder, specifically, Hobson Construction Company and Rogers Plumbing and
Heating Company, Inc., and that Chairman Peterson be authorized to execute the contract.

In the case of the electrical contract, the Metropolitan Sewerage District Attorney is herewith instructed to re-advertise the bids on this work.

Mr. Dawson moved that the resolution be adopted and Mrs. Swicegood seconded the motion. The roll call vote was unanimous.

Mr. Johnson mentioned that boiler flues at the main plant will require \$2,500 worth of work. Mr. Hendon stated he will go back and check to see if perhaps the manufacturer could be at fault since flues usually last much longer than the three years which these have been in use.

Mr. Johnson mentioned a request of transfer of funds of \$8,894.29 to the Revolving Fund for right-of-way purposes, a resolution having been adopted at the January 20, 1970 meeting.

The Gerber surcharge was again discussed and Mr. Hendon recommended that it remain as it is until December, 1970 when a full year's operation can be tabulated. Mr. Redmond also suggested that we continue until November 1, and then increase the base rate by any losses that occur and that we should have the experience of a 12-months' operation. After a lengthy general discussion in which Mr. Dawson and Mrs. Swicegood urged immediate surcharge adjustment, Mr. Dawson moved that we accept Mr. Hendon's recommendation as modified by Mr. Redmond's suggestion to defer action on the matter until the November meeting by the Board. Mrs. Swicegood seconded the motion and the roll call vote was unanimous.

There being no further business, the meeting adjourned at 3:30 p. m.

Gentlemen:

Bids were received by the District July 17, 1970 for the construction of the Crescent Hill Sewage Treatment Plant and Outfall Sewer. A tabulation of the bids submitted is attached.

We recommend that these contracts for the outfall sewer and sewage treatment be awarded to the low bidder, Hobson Construction Company, and that the plumbing contract be awarded to Rogers Plumbing and Heating Company, Inc., the low bidder, and that the Chairman and Secretary be authorized to execute these contracts.

Only two bids were received for the electrical contract. We understand the Engineer-Manager is re-advertising this section of the work.

The low bidder on the Sewage Treatment Plant offered a deduction of \$14,400.00 for substituting an alternate bid on the principal plant equipment. We are checking the specifications on this alternate and will recommend to the Engineer-Manager its acceptance or rejection.
