METROPOLITAN SEWERAGE DISTRICT BOARD

JULY 19, 1988

1. Call to Order and Roll Call:

The Annual meeting of the Metropolitan Sewerage District Board was held in the Boardroom of MSD's Administration Building at 2 p.m. on Tuesday, July 19, 1988. Chairman Smith called the meeting to order at 2:05 p.m.

Chairman Smith and the following members were present: Aceto, Boggs, Dent, Dyson, Edwards, Ivey, Pope, Waddey and Williams. Others present were: W.H. Mull, Engineer-Manager, Dean Huber and Bill Morris, representatives of the Consulting Engineers, and John S. Stevens, General Counsel for the District.

2. Minutes of June 21, 1988:

Mr. Boggs moved that the Board minutes of June 21, 1988 be approved as written. Mrs. Pope seconded the motion, and voice vote was unanimous in favor of the motion.

3. Election of Officers (Chairman and Vice-Chairman):

Chairman Smith opened the floor for nomination of officers. Mr. Boggs moved that the present slate of officers, Mr. Frank S. Smith, Chairman, and Mr. Leon Williams, Vice-Chairman, be reelected for another year. Mr. Edwards seconded the motion and voice vote was unanimous in favor of the motion.

4. Appointment of Officers (Secretary-Treasurer & Assistant Secretary-Treasurer):

Mr. Aceto moved that Mr. Charles Dent, Secretary-Treasurer, and Mrs. Jackie Pope, Assistant Secretary-Treasurer, be appointed to serve for another year. Mr. Waddey seconded the motion, and voice vote was unanimous in favor of the motion.

5. REPORT OF ENGINEER-MANAGER:

a. Status of Phase III Plant Expansion Contracts:

Section 3 - General Work

Mr. Mull reported that Republic Contracting Corporation is progressing on RBC Basin #1 and approximately 42% of the concrete has been placed. Air piping to RBC Basin #1 is approximately 20% complete. Very little work on other sections of the project has been accomplished. The Contractor has requested payment of \$986,500 including stored materials for 8.8% of the contract and 17% of the contract time has lapsed.

Section 3A - Electrical

King Electric has begun work on installing electrical duct banks from the MSD electrical substation. Minor required conduit in concrete of RBC Basin #1 is being installed. The Contractor has requested payment of \$171,396 including stored materials for 15.8% of the contract and 17% of the contract time has lapsed.

Section 3B - HVAC

Bids were received for this project on June 7, 1988. Low Bidder was Martin Heating & Air Conditioning, Inc. of Hendersonville, North Carolina in the amount of \$133,946. MSD has awarded the contract to Martin Heating & Air Conditioning, Inc. pending approval of the North Carolina Department of Natural Resources & Community Development, and the Environmental Protection Agency.

Section 3C - Plumbing

Bids were received on the project June 7, 1988. One bid was received from Price Piping Company, Inc. in the amount of \$198,440.00. Mr. Mull stated negotiations on the contract will begin Wednesday, July 20, 1988.

b. Proposal for Bacterial Treatment of Grease:

Mr. Mull presented to the Board a proposal from Sybron Chemicals, Inc. in the amount of \$3,150.00, for a one month trial of grease removal from the system. Sybron will have a representative on-site to assist in startup, monitoring the program, and to advise on program and plant operation. Sybron will also be responsible for the final evaluation and preparation of a final report. General discussion followed. Mr. Dent moved that the District accept the proposal of Sybron Chemicals, Inc. in the amount of \$3,150, to treat grease removal in the system for one month. Mr. Waddey seconded the motion and roll call vote was unanimous in favor of the motion.

c. South French Broad Relief Interceptor Sewer Easement Acquisitions:

Mr. Mull reported that there are approximately 5 property owners involved in this project, from which the District will require an easement. Two property owners, Mrs. Hope Ryan and Mr. W. C. Hicklin, have consented to sign sewer easements across their property for compensation. These documents have been reviewed by General Counsel and are in acceptable form. Mr. Mull requested that the Board authorize the District to make payment and secure the owners' signatures for easement. Mr. Williams moved that the Board authorize payment in the amount of \$500.00 for Mrs. Hope Ryan for easement, and payment in the amount of \$800.00 for Mr. W. C. Hicklin for easement. Mr. Edwards seconded the motion. Roll call vote was passed by the following vote:

d. Status of Proposed Sludge Disposal Facilities (Phase IV, Plant Expansion):

Mr. Mull reported that he met with a representative from the Environmental Protection Agency, Mr. Robert Freeman, along with a Consulting Engineer of Engineering-Science, Mr. Roy Walden, concerning this project on July 13, 1988. General discussion followed. Mr. Mull stated the District should be hearing from the EPA in the next few weeks.

e. Status of Contract for Interim Floating Aeration Equipment to Boost Activated Sludge System:

Mr. Mull reviewed several documents concerning this contract. Bids were received on July 12, 1988 for the project. This was the second bid date as readvertised due to less than three bids being received on June 28, 1988. One bid was received from Aqua-Aerobic Systems, Inc. in the amount of \$66,844.00. The contractor submitted with his bid several conditions to his bid that the Consulting Engineers have reviewed for their opinion of Aqua's acceptability. Also submitted by Aqua was a detailed cost breakdown of the bid which allowed MSD's Consulting Engineers the opportunity to negotiate and reduce the cost of the project by removing several items from the contractor's scope of work. Hendon Engineering Associates, Inc. recommends awarding the contract to Aqua-Aerobic Systems, Inc., at the negotiated price of \$47,217.60. Mr. Mull also reviewed a Resolution to accept the negotiated bid of Aqua-Aerobic Systems, Inc. in the amount of

\$47,217.60, and award the contract to said bidder, and that the Engineer-Manager be authorized to execute all contracts and documents relating to this purchase of equipment on behalf of the MSD.

The bid of Aqua-Aerobic Systems, Inc. was reviewed by MSD General Counsel, and their comments and recommendations read to the Board.

Mr. Waddey moved that the Board adopt the Resolution accepting the negotiated bid of Aqua-Aerobic Systems, Inc. in the amount of \$47,217.60, and award the contract to said bidder, and that the Engineer-Manager be authorized to execute all contracts and documents relating to this purchase of equipment on behalf of the MSD. Mr. Aceto seconded the motion. Roll call vote was unanimous in favor of the motion. A copy of the Resolution is attached herewith and made a part of these minutes.

7. Report of Committees:

a. Budget Committee - Mr. Batts

(1) Year-End Amendment of FY 1987-88 Operation & Maintenance Budget:

Mr. Mull gave the report of the Budget Committee in Mr. Batts' absence, and reviewed the Resolution to amend the Operation and Maintenance Budget for Year End 1987-88. Mr. Boggs moved that the Board adopt the Resolution amending the Operation & Maintenance Budget for FY 1987-88. Mr. Dent seconded the motion, and roll call vote was unanimous in favor of the motion. A copy of the Resolution is attached herewith and made a part of these minutes.

b. Sewer System Consolidation Committee - Mr. Aceto

Mr. Aceto reported that the Sewer System Consolidation Committee met July 6, 1988, and at this time, there was further refinement of the options previously presented for consolidation. Another meeting has been scheduled for August 3, 1988, and at that time the Committee will present to the City Officials options for consolidation which would eventually be presented to all system owners.

8. Unfinished Business:

(1) Status of U.S. Fish and Wildlife and N.C. Wildlife Resources Commission Matters:

Mr. Mull presented to the Board a copy of Verified Petition for a Contested Case, Metropolitan Sewerage District of Buncombe County, North Carolina, Petitioner, vs. North Carolina Wildlife Resources Commission of the North Carolina Department of Natural Resources and Community Development, Respondent, and turned the floor over to Mr. Jack Stevens, General Counsel for review of the Petition. No action was required at this time by the Board.

9. New Business:

Mr. Mull reported that over the weekend of July 9th, the State Officials and Television Channel 13 had been notified that the District was bypassing waste into the river. It was noted that the bubbler control in the wet well caused the problem, and this has been repaired. The North Carolina Department of Natural Resources and Community Development personnel did visit the plant, and the District should be getting a letter from the State concerning this problem.

10. Date of Next Regular Meeting - August 16, 1988

5c. South French Broad Relief Interceptor Sewer Easement Acquisitions:

At this time Mr. Jack Stevens, General Counsel, excused himself from the meeting, and the easement concerning Mr. William Cecil's property was discussed by the Board. No action was taken at this time.

There being no further business, the Board meeting was adjourned at 3:30~p.m.
