BOARD OF THE METROPOLITAN SEWERAGE DISTRICT FEBRUARY 18, 2015

1. Call to Order and Roll Call:

The regular monthly meeting of the Metropolitan Sewerage District Board was held in the Boardroom of MSD's Administration Building at 2:00 p.m., Wednesday, February 18, 2015.

Chairman VeHaun presided with the following members present: Ashley, Belcher, Bryson, Kelly, Manheimer, Pelly, Root, and Watts. Ms. Frost, Mr. Stanley and Ms. Wisler were absent.

Others present were: Thomas E. Hartye, General Manager, William Clarke, General Counsel, Forrest Westall with McGill Associates P.A., and MSD Staff, Ed Bradford, Scott Powell, Peter Weed, Ken Stines, Mike Stamey, Jim Hemphill, Matthew Walter, Hunter Carson, Angel Banks, and Sondra Honeycutt.

2. Inquiry as to Conflict of Interest:

Mr. VeHaun askef if there were any conflicts of interest with the agenda items. No conflicts were reported.

Mr. VeHaun welcomed Forrest Westall with McGill Associates P.A. Mr. Westall stated he appreciates the opportunity to serve with MSD. While serving on the regulatory side for years, he worked with MSD; who always had an excellent program, professional staff and were very responsive. He further stated he knows he cannot fill Gary McGill's shoes, but will do his best to support MSD in any way he can.

3. Approval of Minutes of the January 21, 2015 Board Meeting:

Mr. VeHaun asked if there were any changes to the Minutes of the January 21, 2015 Board Meeting. With no changes, Mr. Watts moved for approval of the Minutes as presented. Mr. Root seconded the motion. Voice vote in favor of the motion was unanimous.

5. Informal Discussion and Public Comment:

Mr. VeHaun called for public comment. There was no public comment.

6. Report of General Manager:

Mr. Hartye welcomed Forrest Westall. He reported Mr. Westall served for 28 years with NCDENR and headed up the regional office in Asheville as their Water Quality Supervisor. Since 2005 Mr. Westall has been with McGill Associates P.A. Currently he is serving as Executive Director of the Upper Neuse River Basin Association and served as a Member of the EMC in Raleigh. He obtained his Bachelor/ Masters Degree from NC State University; is a registered Engineer and, a recipient of the Friend of the River award from The Land of the Sky Regional Council, as well as The Order of the Long Leaf Pine award. Mr. Westall resides in Burnsville, NC, and has three (3) children. Mr. Hartye stated that he and Staff have worked with Forrest in the past, and not only is he extremely smart, but fun to work with.

Mr. Hartye reported that the District received the Distinguished Budget Presentation Award from the Government Finance Officers Association (GFOA). He expressed his thanks for the great effort put forth by Teresa Gilbert and Scott Powell. Minutes February 18, 2015 Page Two

> Mr. Hartye presented a copy of a letter from Ann Cary Hevener of Mt. Vernon Circle regarding Wesley Banner and Mike Presley from MSD along with the crew from Terry Brothers Construction. Mr. Harvey Kreider emailed to express his pleasure with the hard work the MSD crew did in handling a tough sewer line backup on his property below his house. He stated the crew showed their expertise and handled the situation in a timely manner. Much thanks to Shane Meadows, Marvin Felder, Carl Ellington, Jamie Fox, and Billy Cantrell. Also, Jimmy Boyd of Glen Falls Road called to let MSD know how much he appreciated the MSD folks helping him and his wife work through issues at his mother-in-laws house after her passing. 7. Consolidated Motion Agenda:

a. Consideration of Bids – MSD Incinerator System Emissions Upgrades.

Mr. Hartye reported the original Incinerator was constructed in 1992, and a major rehabilitation project was completed in 2005. He stated this project involves the installation of new equipment to meet future EPA-mandated regulations and involves the upgraded of the existing Venturi scrubber and heat exchanger. The original scope of the project included an activated carbon system, with an estimated construction cost of \$10.3 million. This technology, while proven and most commonly used, has significant costs. MSD has taken a different path and pilot tested a new technology which performed well (>90%) and will save \$5million from using the conventional system. In order to accommodate lead times for equipment manufacturing, MSD preapproved the Venturi Manufacturer at the November 19, 2014 Board meeting, and then pre-purchased the heat exchanger at the December 17, 2014 Board meeting. The construction/installation contract was advertised in January 2015 and the following bids were received on February 5, 2015: Wharton-Smith, Inc. with a total bid of \$5,482,265.00; H&M Constructors with a total bid of \$5,323,000.00; Haren Construction Co., Inc. with a total bid of \$5,318,000.00, and Industrial Furnace Co., with a total bid of \$3,745,000.00. However, the apparent low bidder, Industrial Furnace Co., is not a licensed General Contractor in NC, therefore their bid was rejected. Haren Construction is the lowest responsive bidder and has completed the previous incinerator rehabilitation project for MSD in 2005 and their work quality was excellent.

Mr. Hartye further reported this type of project is somewhat different in that it has a sub-contractor (a Systems Integrator). There were two firms that were pre-approved prior to the bid being let. Hankin, who worked on the previous project, was the only one giving sub-contracting bids. Industrial Furnace Co. from New York, not only submitted a General Contractor bid, but submitted their qualifications as a Systems Integrator, with 48 years of experience. Thru the bid process, they were approved, based on their qualifications, to become an eligible Systems Integrator. Because MSD Engineers estimated the price to be around \$4.5 million, they negotiated a lower price with the lowest responsive bidder, Haren Construction Co., Inc. Mr. Hartye expressed his thanks to Hunter Carson, Ed Bradford, and John Lapsley, with CDM Smith, who worked very hard during negotiations in reducing the cost by \$700,000.00 to \$4,624,000.00. Mr. Hartye presented the Bid Tab; Letter from Haren, and the Budget sheet. The combined construction cost, including the previously approved heat exchanger, is \$5.3 million. The multi-year construction budget is \$10.3 million for this work. Staff recommends award of the construction/installation contract to Haren Construction Co., Inc. in the amount of \$4,624,000.00.

b. Consideration of Developer Constructed Sewer Systems: Carmel Ridge Apartments Sewer Extension; Goldmont Street Sewer Extension, and Reems Creek Cottages Sewer Extensions.

Mr. Hartye reported the Carmel Ridge Apartments Sewer Extension project is located outside the District boundary off New Leicester Highway in Buncombe County. The project included extending approximately 1,126 linear feet of 8-inch public gravity sewer to serve the eighty (80) unit apartment complex. The Goldmont Street Sewer Extension project is located inside the District boundary off Goldmont Street in the Town of Black Mountain. The project included extending approximately 90 linear feet of 8-inch public gravity sewer to serve the six (6) unit residential development. The Reems Creek Cottages Sewer Extension project is located outside the District boundary off Reems Creek Road in the Town of Weaverville. The project included extending approximately 495 linear feet of 8-inch public gravity sewer to serve the seventeen (17) unit residential development. Mr. Hartye further reported that staff recommends acceptance of the aforementioned developer constructed sewer systems. All MSD requirements have been met.

c. Second Quarter Budget to Actual Review – FY2015:

Mr. Powell reported that page 29 is the District's first quarter Budget to Actual Revenue and Expenditure Report. Domestic and Industrial User Fees are at budgeted expectations. Facility and Tap Fees are above budgeted expectations due to receiving approximately \$774,000 from three developers. Interest and miscellaneous income are slightly below budgeted expectations. Fixed income investment yields are lower than expected due to the continued Federal Reserve policy of keeping short-term rates near zero percent. O&M expenditures are at 49.74% of budget. They include encumbered amounts (\$487,000). These amounts will be spent in future periods. Bond principal and interest expenditures are reflected at 50%. This will aid the user to properly assess debt service commitments on a budgetary perspective. Actual amount spent as of the end of the first quarter is 3.8%. This is due to the timing of the District's debt service payments. Amounts budgeted for capital equipment and projects, this amount is considered reasonable.

d. Cash Commitment/Investment Report – Month Ended December 31, 2014:

Mr. Powell reported that page 31 presents the makeup of the District's Investment Portfolio. There has not been a significant change in the makeup of the portfolio from the prior month. Page 32 is the MSD Investment Managers report as of the month of December. The weighted average maturity of the investment portfolio is 220 days. The yield to maturity is .43% and is exceeding MSD bench marks of the 6 month T-Bill and NCCMT cash portfolio. Page 35 is the MSD Variable Debt Service report. The 2008 Series Bonds are performing better than budgeted expectations. Mr. Powell noted that during the entire month of January, the bonds reset at 1 basis point. The interest rate for the 2008 Series Bonds was 2.98%. This was the lowest rate in the Bonds existence. As of the end of December, both issues have saved District customers over \$3.7 million in debt service since April, 2008.

With no discussion, Mr. Pelly moved for approval of the Consolidated Motion Agenda. Mr. Watts seconded the motion. Roll call vote was as follows: 9 Ayes; 0 Nays.

BOARD OF THE METROPOLITAN SEWERAGE DISTRICT JANUARY 21, 2015

1. Call to Order and Roll Call:

The regular monthly meeting of the Metropolitan Sewerage District Board was held in the Boardroom of MSD's Administration Building at 2:00 p.m., Wednesday, January 21, 2015.

Chairman VeHaun recognized Jackie Bryson, representing Woodfin Sanitary Water & Sewer District for her reappointment to the MSD Board, as well as Councilwoman Gwen Wisler representing the City of Asheville. Chairman Vehaun called on Ms. Wisler for any comments. Ms. Wisher stated she is looking forward to learning more about the MSD organization and appreciates the opportunity to serve. Chairman VeHaun and Vice Chairman Kelly presented Ms. Wisler with the traditional manhole puller. After the presentation, the roll was called with the following members present: Ashley, Belcher, Bryson, Frost, Kelly, Pelly, Root, Stanley, Watts and Wisler. Ms. Manheimer was absent.

Others present were: Thomas E. Hartye, General Manager, William Clarke, General Counsel, Gary McGill with McGill Associates P.E., Joseph Martin with Woodfin Sanitary Water & Sewer District, Jonathan Kanipe, Town Administrator, with the Town of Biltmore Forest, Patty Beaver with CIBO, and MSD Staff, Ed Bradford, Scott Powell, Peter Weed, Ken Stines, Mike Stamey, Matthew Walter, Jim Hemphill, Angel Banks, and Sondra Honeycutt.

2. Inquiry as to Conflict of Interest:

Mr. VeHaun asked if there were any conflicts of interest with the agenda items. No conflicts were reported.

3. Approval of Minutes of the December 17, 2014 Board Meeting:

Mr. VeHaun asked if there were any changes to the Minutes of the December 17, 2014 Board Meeting. With no changes, Mr. Stanley moved for approval of the Minutes as presented. Mr. Watts seconded the motion. Voice vote in favor of the motion was unanimous.

4. Discussion and Adjustment of Agenda:

5. Informal Discussion and Public Comment:

Mr. VeHaun welcomed Mr. Kanipe, Mr. Martin, and Ms. Beaver. There was no public comment.

6. Report of General Manager:

Mr. Hartye called on Gary McGill, who asked to address the Board. Mr. McGill stated that most Board members were aware of his home being destroyed by fire several months ago. He reported that a lighting strike burnt down the entire house, all the contents, and vehicles. Fortunately, they were not home at the time. Over the intervening months, they have been in the recovery phase in dealing with insurance, etc. At this point he feels he needs more time to complete this process, but is not sure how long it will take. He stated he has been the Engineer of Record since the mid 1990's, but the title is actually McGill Associates. He suggested that in his absence, Forrest Westall, with McGill Associates, be brought in to fill this position. However, if he is needed in the interim, he will be happy to help in any way he can. Mr. VeHaun stated he appreciates what Gary has done for the Board and MSD and is happy he will still be around. Mr. Hartye added that Gary will be missed and hopes to see him back soon. Mr. Stanley

> asked if any action needs to be taken. Mr. Clarke said no, since the Engineer of Record is the company McGill Associates. Mr. Hartye stated MSD has worked with Forrest Westall and that he is up to speed on a lot of the issues, particularly having to do with the plant and treatment, and at one time, was head of the DENR regional office.

> Mr. Hartye presented a copy of an AC-T article regarding "non-flushable" items and how the treatment plant handles them. Included is a video link of a tour with Peter Weed, Wastewater Treatment Director, as well as a link on MSD's main site concerning the main culprit "flushable wipes" which do not disperse after flushing and clog up the waste collection and treatment system. He presented a video clip showing regular toilet paper and how it disperses in water; a clip showing facial tissue, which does not break up in the water, and flushable wipes that do not break up at all, and get caught up on pumps in the pump stations and create havoc. Mr. Hartye stated in the past, MSD had a big campaign having to do with grease, which clogs up the system, and the combination of grease and wipes is even worse. Mr. Watts suggested MSD start a campaign against wipes, like it did against the grease.

> Mr. Hartye reported that MSD received a call from Reid Patton of 51 Ambler Road expressing her appreciation for Roy Lytle. She said he was there a couple of weeks ago and was extremely professional, very nice and friendly. A call was received from Robert Milnes of 10 Meadowview Road expressing his appreciation for the fast work and great job done at his address. He expressed his thanks to McKinley Hensley, Travis Chandler, Robert Denny, and John Matthews. Also, a call was received from Randy Mahaffey of 439 Overlook Road about the outstanding job MSD employees did. He expressed his appreciation to Wayne Rice who came out first to check the problem out, and to the dig up crew, Mitchell Metcalf, Roy Lytle, McKinley Hensley, Robert Denny and Travis Chandler. He said they were all very efficient, very nice, very friendly, and did an outstanding job.

> Mr. Hartye reported the ROW Committee Meeting for January is cancelled. The next meeting will be held February 25^{th} at 9 a.m. The next regular Board Meeting will be held on February 18^{th} at 2 p.m.

7. Consolidated Motion Agenda:

a. Consideration of Annual Meeting Dates for FY 2015:

Mr. Hartye presented a copy of the Annual Board Meeting Dates for FY2015. He stated that typically, Board meetings are held on the third Wednesday of each month at 2 pm, with the exception of the June meeting which is held on the second Wednesday to accommodate passage of the annual budget. The Right of Way Committee is held on the 4th Wednesday of each month at 9 am unless cancelled. The Personnel, Finance and CIP Committees meet according to the Budget Calendar. The Planning Committee meets as needed.

b. Consideration of Budget Calendar for FY 2015-2016:

Mr. Hartye presented the District's proposed Budget calendar. He stated that time between Committee and Board meetings has been scheduled to prepare and distribute agenda items, including preparation time for any revisions requested to be presented at a subsequent meeting. The Personnel Committee is slated to convene on April 28. The CIP Committee is slated for April 30th, and the Finance Committee is slated for May 7.

c. Consideration of Bids for Sanitary Sewer Replacement Project – Wendover Road:

Mr. Hartye reported this project is located in West Asheville near Sand Hill Road. The eight-inch line serving the area is in poor structural condition and has experienced SSO's; causing ongoing maintenance problems. The project is comprised of 2,654 LF of 8-inch and 12-inch DIP, and also includes 321 LF of 18-inch interceptor. The contract was advertised and the following bids were received on January 6, 2015: Thomas Construction Co. with a total bid of \$925,807.00; Moore & Sons Site Contractors with a total bid of \$849,951.00; Thunder Disaster Services with a total bid of \$727,293.92; Terry Brothers Construction Co. with a total bid of \$704,877.50; Dillard Excavating Co. with a total bid of \$689,215.00; Buchanan & Sons with a total bid of \$664,106.00, and David Grading, Inc. with a total bid of \$576,269.50. The apparent low bidder is David Grading, Inc. with a bid amount of \$576,269.50. Mr. Hartye reported that Davis Grading has completed a recent MSD rehabilitation project in downtown Black Mountain, and is underway on another project. Their work quality has been excellent on both projects. The FY14-15 Construction Budget for this project is \$753,000.00. Staff recommends award of this contract to David Grading, Inc. in the amount of \$576,269.50, subject to review and approval by District Counsel.

d. Consideration of Contract for Engineering Services – MSD Arc-Flash Study:

Mr. Hartye reported MSD recently completed significant upgrades to the plant's electrical system; 2.5 million over three fiscal years. The first phase was the external power supply. Duke Energy initiated a new Broadway Feeder to supplement the feeds coming into the plant. In addition they installed a new transformer bank @ the substation. Internally, an auto transfer switch was installed and the old switchgear was upgraded to add multiple feeds throughout the plant and added a backup power supply with new 2-MW generators. He presented several slides showing the aforementioned improvements. The next phase is to comply with NFPA 70E regulations to conduct an Arc Flash Study for MSD facilities which include major buildings, the plant, as well as major pumping stations within the collection system. This study will establish safe working limits for the numerous protective devices located throughout MSD facilities. It will accomplish this by testing various circuit breakers and providing a comprehensive study based on the results. Staff advertised a Request for Qualifications in November 2014 and received responses from the following consulting firms: AVO Training Institute; Banta, Hallam ICS; McGill Associates, and Reece, Noland, & McElrath. The Selection Committee evaluated the firms with a weighted scoring system on several criteria. Familiarity with MSD's electrical system (the plant, in particular) is very important and weighted heavily in the scoring system. Since none of the firms, other than McGill had visited the MSD treatment plant, McGill Associates scored the highest and was chosen as the most qualified firm for the project. The FY 14-15 Special Studies Budget for this project is \$125,000.00 and there are sufficient funds within the CIP for the overage. Staff recommends award of the engineering services contract to McGill Associates in the amount of \$138,000.00 subject to review and approval by District Counsel.

e. Cash Commitment/Investment Report – Month Ended November 30, 2014:

Mr. Powell reported Page 27 presents the makeup of the District's Investment Portfolio. There has been no change in the makeup of the portfolio from the prior month. Page 28 is the MSD Investment Manager Report as of the month of November. The weighted average maturity of the investment portfolio is 236 days. The yield to maturity is 0.43% and is exceeding MSD bench marks of the 6-month T-

Bill and NCCMT cash portfolio. Page 29 is the MSD Analysis of Cash Receipts for the month of November as well as YTD. Both the Domestic & Industrial sewer revenues are considered reasonable based on timing of cash receipts in their respective fiscal periods. YTD Facility and Tap fees are considered reasonable based on timing of cash receipts in their respective fiscal periods. Page 30 is the MSD Analysis of Expenditures. O&M, Debt Service, and Capital Project expenditures are considered reasonable based on historical trends and timing of capital projects. Page 31 is the MSD Variable Debt Service report for the month of December. The 2008A Series is performing better than budgeted expectations. As of the end of December, the issue has saved District rate payers approximately \$3.7 million dollars in debt service since April of 2008.

With no discussion, Ms. Frost moved the Board approve the Consolidated Motion Agenda as presented. Mr. Root seconded the motion. Roll call vote was as follows: 11 Ayes; 0 Nays.

8. Old Business:

Mike never let things ruffle him; he kept his team on target and his customers happy. I will always remember his managerial and diplomatic skills. If we all followed the sort of example he set on this project, the world would be, quite simply, a better place.

Thank you for sharing these fine men with us. Thank you for doing all that you said you would do. Thank you for improving our neighborhood infrastructure with a minimum of disruption. I never thought it would be possible to say that the process of getting a new sewer line in our neighborhood would be pleasure, but your terrific team made it so.

BACKGROUND: <u>Summary of Project</u>

The Sewage Sludge Incinerator (SSI) is located at the Water Reclamation Facility. It plays a crucial role in the District's management of biosolids, which are a residual of all wastewater treatment plants. The original SSI was constructed in 1992, and a major rehabilitation project was completed in 2005.

New EPA-mandated regulations impose more stringent air emission limits for all SSI's in the United States (primarily affecting mercury and sulfur dioxide). In addition, there is a short timeline to meet the new rules equipment must be in operation and in compliance by March 2016.

In addition to the new emissions requirements, rehabilitation of high-wear components is necessary. Major components within the system (the venturi and the heat exchanger) have now reached the end of their useful lives and must be replaced.

The original scope of the project included an activated carbon system, with an estimated construction cost of \$10.3 million. This technology, while proven and most commonly used, has significant costs and can be burdensome to maintain over time.

During preliminary engineering, MSD learned of a newer technology which uses replaceable sorbent-polymer modules instead of activated carbon. This technology has been used in other industrial applications, and is far less expensive than carbon. MSD therefore chose to pursue this option, given the amount of funds that could be saved - provided that it met all requirements. MSD then pilot-tested this technology at the plant during summer of 2014, with excellent results. Mercury removal rates exceeded 90% on average. After the successful pilot, MSD then obtained permission from the WNC Air Quality Agency to implement this new technology.

This new sorbent-polymer technology will not only be easier to operate and maintain over time, but it will save MSD over \$5 million in construction costs.

Construction Phase

In order to accommodate lead times for equipment manufacturing, MSD pre-approved the venturi manufacturer at the Nov. 19, 2014 Board meeting, and then pre-purchased the heat exchanger at the Dec. 17, 2014 Board meeting.

The construction/installation contract was advertised in January 2015 and four bids were received on Thursday, February 5, 2015 as follows:

(*) Contractor is not a licensed General Contractor in NC; therefore, bid is rejected.

Haren Construction is the lowest responsive bidder. Haren completed the previous incinerator rehabilitation project for MSD, ca. 2005, and their work quality was excellent on that project. In addition, CDM checked current references for Haren, with excellent results.

Haren Construction's bid amount exceeds the Engineer's Estimate for this work (which is \$4.5 million). In accordance with G.S. 143-129, MSD and CDM Smith negotiated a lower price with Haren. *Haren's reduced bid amount is* **\$4,624,000.00.** The lower price is primarily the result of using a different subcontractor, whose references also checked out well.

Please refer to the attached documentation for further details, including the recommendation by CDM Smith and District Counsel's review.

- **FISCAL IMPACT:** The combined construction cost, including the previously approved heat exchanger, is \$5.3 million. The multi-year construction budget is \$10.3 million for this work.
- **STAFF RECOMMENDATION:** Staff recommends that the District award the construction/installation contract to Haren Construction Co., Inc. in the amount of \$4,624,000.00.

CDM Smith has completed our review of the bids received on February 5, 2015 for the Incinerator System Rehabilitation and Emissions Upgrades Project.

In review of the bid submission it was identified that the apparent low bidder, Industrial Furnace Company, does not hold a current North Carolina General Contractor's license which is required by North Carolina Law in order to submit a bid for the work associated with this project. Accordingly, the Industrial Furnace Company bid has been declared non-responsive and eliminated from consideration. Haren Construction Company, Inc. was the second low bid on the project.

CDM Smith reviewed the bid submission from Haren Construction Company, Inc. and found it to be in compliance with the bid requirements including licensure, qualifications/references and bid security. CDM Smith also contacted several references which all provided positive comments regarding Haren Construction Company's qualifications and ability to perform work of this type. Haren Construction Company is considered the lowest responsive, responsible bidder on the project with an original bid price of \$5,318,000.00.

The original bid price from Haren Construction Company exceeded the Engineer's Opinion of Probable Construction Cost of \$4,500,000 for the construction of this portion of the project. With the approval of MSD legal counsel, CDM Smith and MSD staff have negotiated with Haren Construction Company to make reasonable changes to the plans and specifications (as allowed by North Carolina General Statute 143-129) in an effort to bring the price within the MSD budget.

Haren Construction Company has summarized their efforts to reduce the price for the work in their letter dated February 11, 2015 which includes a revised bid price of \$4,624,000.00. CDM Smith has reviewed this letter and the identified changes to the plans and specifications and is in agreement that these are acceptable without compromising the intent of the project scope.

We are very pleased to learn that that we were the low bidder on the referenced project. We understand that the project is over budget as bid, and we appreciate the opportunity to work with you on ways to reduce the project cost. We are happy to offer a value engineered price of \$4,624,000.00 (Four million, six hundred twenty-four thousand dollars). This price is the result of the combined efforts of Haren Construction Company (HCCI), Industrial Furnace Company (IFCO), and CDM Smith, and is the best we could do with the given time constraints. We will be happy to continue to look for ways to further reduce the cost, if so directed. As priced, we would utilize IFCO as the Fluidized Bed Incinerator Emission System Supplier (FBIES Supplier) and a major subcontractor on the project.

In order to reduce costs, CDM Smith agreed to reduce the number of days allotted for submittal review to 20 calendar days for single discipline reviews and 30 calendar days for multi-discipline submittal reviews, and they committed to work with IFCO and HCCI to address any submittal comments to minimize multiple review cycles. The Sewage Sludge Incinerator (SSI), located at MSD's Water Reclamation Facility (WRF) is crucial to the management of biosolids, as it is currently the only viable disposal option available to MSD. The SSI was placed into service in 1992 and is permitted to process up to 40 dry tons of dewatered sludge per day. MSD currently processes approximately 15 dry tons of sludge per day. Due to the extreme nature of the incineration process (i.e. high temperatures and corrosive gases), several components of the SSI have deteriorated over time.

This project consists of the replacement of these components, including, but not limited to the heat exchanger (waste heat recovery system), venturi scrubber (particulate removal system), and associated exhaust piping. The project also includes the installation of a mercury scrubber to comply with newly established federal emission guidelines, which take effect on March 21, 2016. Details of this legislation (known as EPA's MACT Rule), as well as an overview of the rehabilitation project were covered during the August 21, 2013 MSD Board meeting, and the CIP Committee meeting in May 2014.

In order to meet the MACT compliance deadline, MSD and its consulting engineer, CDM Smith, maintained a strict schedule. Measures were taken to ensure that crucial pieces of equipment, specifically the new heat exchanger, venturi scrubber, and mercury scrubber arrive on site in a timely manner. MSD approved a sole-source specification of the venturi and mercury scrubbers, manufactured by EnviroCare International, as well as proceeding with the production of engineering submittals for both pieces of equipment. These items were approved at the November 19, 2014 MSD Board meeting.

MSD also approved the pre-purchase of the new primary heat exchanger from Thermal Transfer, as this item has a long lead time of approximately 9 months. This was approved at the December 17, 2014 MSD Board meeting. By initiating these steps, delivery times for major pieces of equipment have been reduced by more than two months, in turn allowing additional time at the end of the project for sufficient equipment implementation and MACT compliance testing.

On February 5, 2015 at 2:00pm, four sealed bids were received for the Incinerator System Rehabilitation & Emissions Upgrade project. Results were as follows:

Upon review of the bid submission from Industrial Furnace Company Inc., it was identified that Industrial Furnace Company Inc. was not a licensed General Contractor in the State of North Carolina at the time of the bid. In accordance with NC General Statute 87-1 and 87-13, all bidding Contractors must be licensed at the time of bid submission. Therefore, Industrial Furnace Company Inc.'s bid was determined non-responsive and was removed from consideration, making Haren Construction Company, Inc. the apparent low bidder.

The Fiscal Year 2014/15 CIP budget included \$10.3M for the construction of the said project; however, during design, MSD explored and ultimately adopted an alternative mercury control technology, saving the District close to \$5M in capital costs. As a result, CDM Smith's final construction estimate prior to bidding was \$4,500,000. Because all (responsive) bids exceeded the Engineer's estimate, North Carolina General Statute 143-129 allowed MSD to negotiate with the apparent low bidder, Haren Construction Company, Inc. in order to bring the contract price to within (or closer to) the Engineer's estimate.

Haren Construction Company, Inc. worked in parallel with CDM Smith and its subcontractors to lower its contract price without compromising project quality. Ultimately, Haren Construction Company offered a value-engineered price of \$4,624,000.00. While this price still exceeds the Engineer's estimate, MSD and CDM Smith feel that this is a fair and reasonable price.

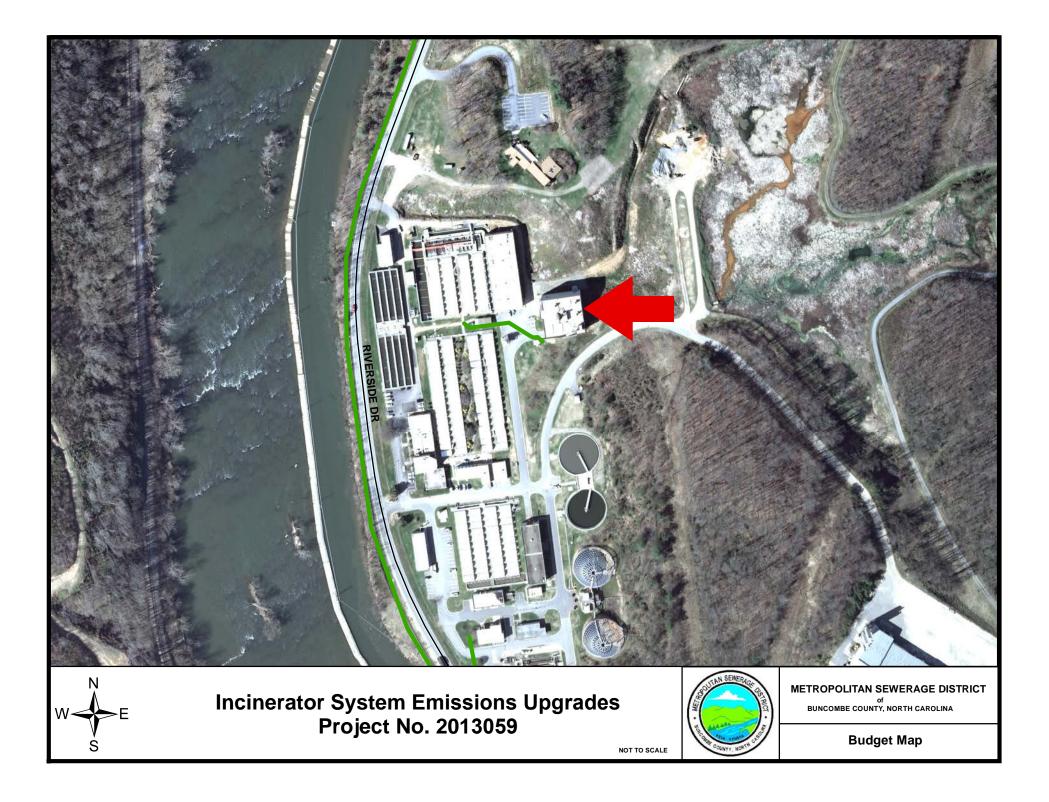
Haren Construction Company, Inc. has worked for MSD on a previous incinerator rehabilitation project in 2004. The project included the installation of a new heat exchanger, new gas duct and process air piping, replacement of incinerator refractory lining, and an upgrade to the fluidizing air blowers and controls. MSD Staff was very pleased with the quality of work provided by Haren Construction Company, Inc. and recommends their services for the current project. CDM Smith also contacted current references, included as part of Haren's bid package, and received positive feedback from all contacts.

Staff recommends that this project be awarded to Haren Construction Company, Inc. of Etowah, TN in the amount of \$4,624,000.00, subject to MSD Counsel's review and approval of the bids.

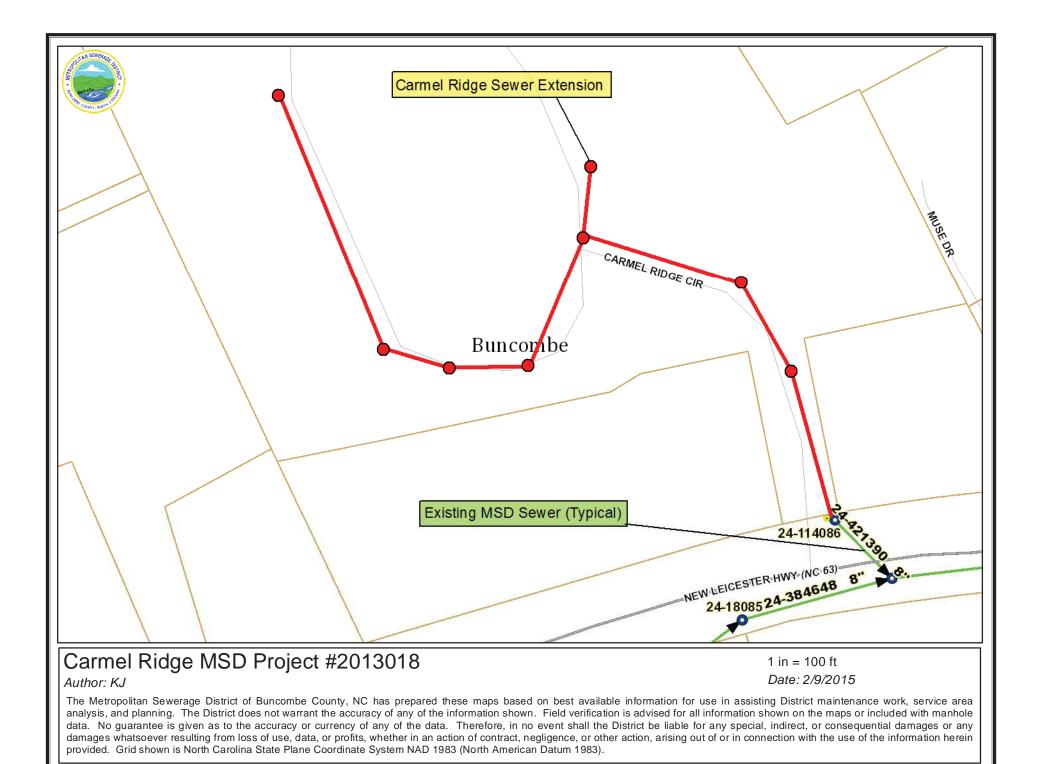

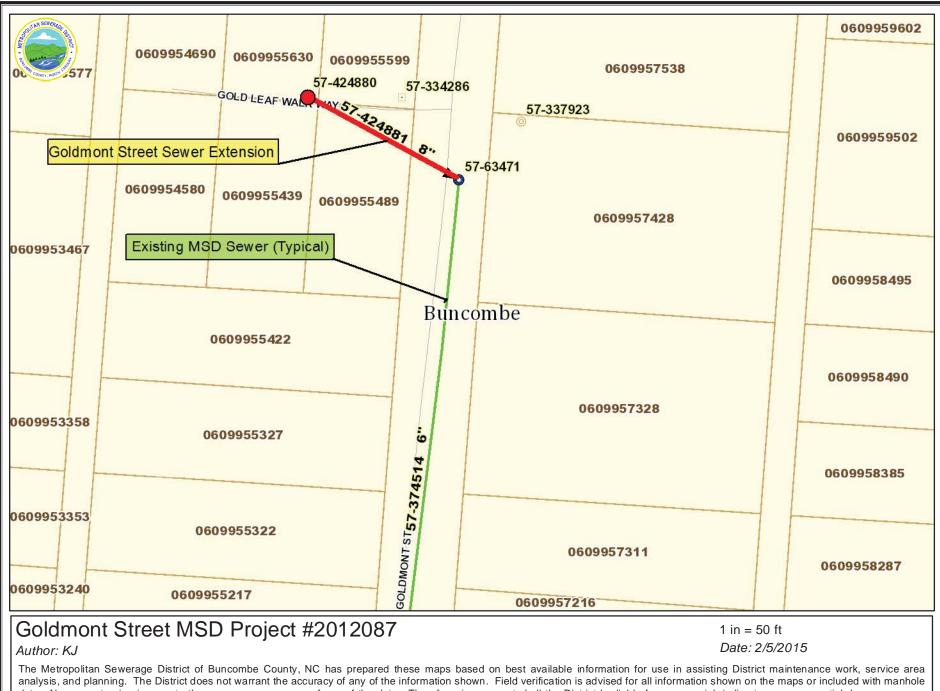

Background

At the end of each quarter, actual revenue and expenditure amounts are compared with the budget to evaluate the District's financial performance. The attached schedule includes year-to-date actual amounts as of December 31, 2014 as well as the adopted budget for FY15.

Discussion

There are several explanatory notes at the bottom of the page to assist in using this schedule as a management tool. Other considerations are as follows:

- Domestic and Industrial User Fees are at budget expectations. Staff monitors consumption trends as they
 have a direct effect on the District's current and future revenue projections.
- Facility and Tap Fees, also conservatively budgeted, can be significantly higher or lower than budget.
 Facility and Tap fees are above budgeted expectations due to receiving unanticipated revenue of \$774,000 from three commercial/residential developers and a number of taps requiring bore/pavement disturbance.
- Interest and miscellaneous income are slightly below budgeted expectations. Fixed income investment yields are lower than expected due to continued Federal Reserve policy of keeping short-term interest rates near zero percent.
- Rental income reflects expected earnings.
- O&M expenditures are at 49.74% of budget. The expenditures include encumbered amounts and are at budget expectations. The aforementioned encumbrances will be spent in the future periods.
- Bond principal and interest expenditures are reflected at 50%. This will aid the user to properly assess the District's overall debt service commitments. Actual amount spent is 3.8%, due to the timing of the District's debt service payments. The District is required to make a semi-annual interest payment on January 1, 2015 and a principal and semi-annual interest payment on July 1, 2015.
- Amounts budgeted for capital equipment and capital projects are rarely expended proportionately throughout the year and are expected to be fully spent prior to the end of the year.

Metropolitan Sewerage District Yield Comparison - December 31, 2014

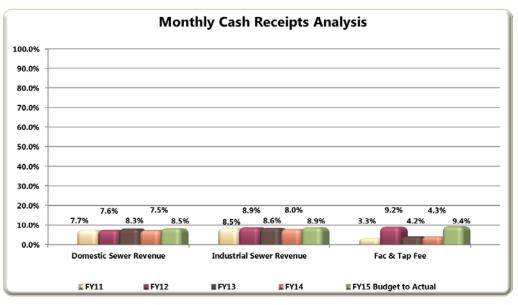

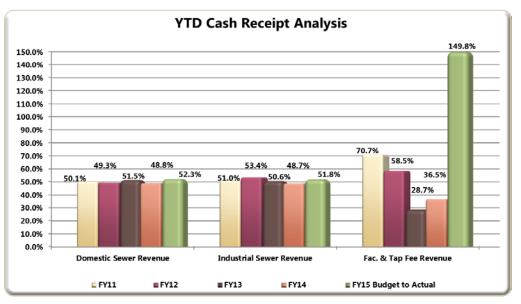
METROPOLITAN SEWERAGE DISTRICT **ANALYSIS OF CASH RECEIPTS** As of December 31, 2014

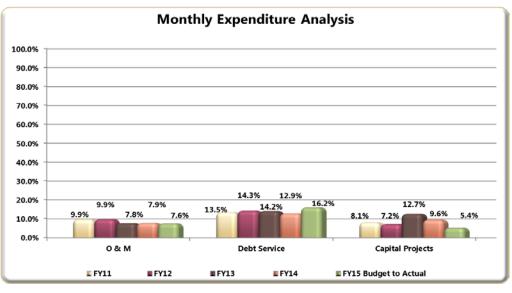

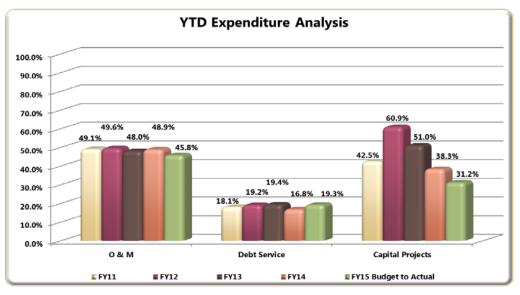
