# 1. Call to Order and Roll Call:

> The regular monthly meeting of the Metropolitan Sewerage District Board was held in the Boardroom of MSD's Administration building at 2pm Wednesday, August 16, 2017. Chairman VeHaun presided with the following members present: Bryson, Creighton, Kelly, Pressley, Root and Wisler. The following members were absent: Ashley, Collins, Frost, Manheimer and Pelly.

> Others present were: Thomas E. Hartye, General Manager; William Clarke, General Counsel; Forrest Westall with McGill Associates; Marcus Jones and Commissioner Bill Lapsley with Henderson County; Joseph Martin with Woodfin Sanitary Water & Sewer District; Ed Bradford, Scott Powell, Jim Hemphill, Matthew Walter, Peter Weed, Mike Stamey, Ken Stines, Hunter Carson, Spencer Nay and Pam Nolan.

# 2. Inquiry as to Conflict of Interest:

Mr. VeHaun asked if there were any conflicts of interest with the agenda items. No conflicts were reported.

# 3. Approval of Minutes of the July 19, 2017 Board Meeting:

Mr. Vehaun asked if there were any changes to the Minutes of the July 19, 2017 Board Meeting. Mr. Creighton moved for approval of the minutes as presented. Mr. Root seconded the motion. Voice vote in favor of the motion was unanimous.

# 4. Discussion and Adjustment of Agenda:

# 5. Informal Discussion and Public Comment:

Mr. Vehaun welcomed Marcus Jones, Bill Lapsley and Joe Martin. There was no public comment.

# 6. **Report of General Manager:**

Mr. Hartye reported that Commissioner Bill Lapsley and County Engineer Marcus Jones were present to address the Board. Mr. Lapsley introduced himself and stated that he is a member of the Henderson County Board of Commissioners and, based on past experience, finds himself in the default position of dealing with all things water and sewer related in Henderson County. Mr. Lapsley stated that he is in attendance today on behalf of his fellow Commissioners to thank the District for support on the recent action of the General Assembly. He further commented that he is sure all are aware than an action was passed whereby this Board has the option to expand and include what is now a significant portion of the Cane Creek

Water and Sewer District in Henderson County. The Cane Creek Water and Sewer District consists of about 3,600 customers who discharge into the District's system. The first step in this process was for the Henderson County Commissioners to pass a resolution of intent. This Resolution was passed by the Henderson County Board on July 19, 2017 and is included with this Board package. Mr. Lapsley stated that over the next 8-9 months he anticipates further discussions between Henderson County and the District to work through the numerous steps and that he looked forward to working with the District. He stated that again his primary role today was to thank the District for their position in the past on this action in legislature and that they look forward to working with the District in the months and years ahead. Mr. Vehaun asked if there were any questions or comments. There were none. Mr. Hartye reported that Cane Creek Water and Sewer flow does come to the District for treatment. At this time, the District does not maintain Cane Creek's local lines and pump stations, which consist of about 60 miles. The District has looked at this issue several times in the past and it looks favorable and makes sense as the drainage basin flows in this direction. Attached is a copy of the Resolution that Mr. Lapsley referred to, followed by a synopsis of the merger process. Mr. Hartye thanked Mr. Bradford for preparing this summary. The first step, as previously stated, is to have the Resolution which we have today. The second step is for this Board to accept or reject the request. Mr. Hartye stated that after talking with Chairman VeHaun, they thought it would be a good idea to send this to Planning Committee. The final document attached is regarding the Etowah private sewage system and is attached only to keep the Board apprised of this information. Mr. Hartye stated that he has been having discussions with Mr. Lapsley and Mr. Jones regarding this matter. Etowah is not currently part of the Cane Creek Water and Sewer District. There has been talk about Etowah coming into their system and it was referred to in their Master Plan as a potential future area but it was not included in their CIP and it was not included in the District's analysis. Mr. Hartye stated that he is being told now that this will likely not happen. Mr. Hartye stated that his recommendation would be to have a group of representatives consisting of Mr. Clarke, Mr. Westall, Mr. Root and himself to meet with Henderson County representatives and bring something back to the Planning Committee. Mr. VeHaun stated that he would like to officially refer this matter to the Planning Committee, who will then bring a report back to this Board. There were no questions or comments regarding this matter.

Mr. Hartye reported that attached is a blurb from Hartwell Carson, French Broad River Keeper, which was in the ACT editorial section regarding the System Services folks providing emergency response 24/7/365. Mr. Carson happened to be on site and witnessed this and the District appreciates him bringing this up.

Mr. Hartye reported that attached is an e-mail from Ed King regarding MSD's CIP Document.

> Mr. Hartye reported that attached is a list of classes for the Collections System Operators School which MSD heads up for the WNC faction of NCAWWA/WEA. Mr. Hartye thanked all who provided great instruction to further the future of our industry.

> Mr. Hartye reported the next regular Board Meeting will be held September 20<sup>th</sup> at 2pm. The next Right of Way Committee meeting will be held on September 27<sup>th</sup> at 9am.

> Mr. Hartye reported that Paul Wilkins, an MSD mechanic, passed away and he asked everyone to keep Mr. Wilkin's family in their thoughts and prayers.

# 7. Consolidated Motion Agenda:

# a. Consideration of Equipment Proposals: Sodium Hypochlorite Tank Replacement:

Mr. Hartye reported that all wastewater plants are required to disinfect effluent prior to discharging into the river. MSD uses sodium hypochlorite for this purpose. Previously, chlorine gas was utilized until 2002. There are four tanks holding the sodium hypochlorite, at 15,000 gallons each. These tanks are now past their functional life span and must be replaced. Staff obtained quotes from two regional companies which manufacture chemical storage tanks as follows: Southeastern Fiberglass Products in the amount of \$118,000.00 and Augusta Fiberglass in the amount of \$94,658.00. The apparent low bidder is Augusta Fiberglass with a bid amount of \$94,658.00. The FY 17-18 Construction Budget for this project is \$183,000.00, which also includes funds for the removal of the old tanks and installation of the new tanks. Staff recommends award of this equipment procurement to Augusta Fiberglass in the amount of \$94,658.00, subject to review and approval by District Counsel.

# b. Consideration of Equipment Proposals: Blower MCC Replacement:

Mr. Hartye reported that the MCC (Motor Control Center) replacements are for the Rotating Biological Contactors (RBC's) at the plant. The air is used to rotate the RBC's. The blowers were replaced in 2008. However, the starters were not replaced. The replacement units will be "soft starters" which help reduce both startup current and stress on the motors when they cycle on and off. Staff obtained quotes from manufacturers of this equipment follows: as Rockwell two Automation/Allen-Bradley in the amount of \$209,872.00 and Eaton in the amount of \$202,000.00. The apparent low bidder is Eaton with a bid amount of \$202,000.00. Eaton is a local manufacturer based in Arden, NC, which is beneficial for service and parts availability. The FY 17-18 Construction Budget for this project is \$375,000.00, which also includes costs for ancillary equipment and installation. Staff recommends award

of this equipment procurement to Eaton in the amount of \$202,000.00, subject to review and approval by District Counsel.

# c. Consideration of Bids: Hendersonville Road at Peachtree Road GSR:

Mr. Hartye reported that this project is located in South Asheville along Hendersonville Road, in front of Walmart. It consists of 1,150 LF of 8-inch DIP, to be installed by dig and replace. The contract was formally advertised on July 27, 2017, and two bids were received as follows: Thomas Construction Company in the amount of \$486,400.00 Terry Brothers Construction Company in the amount and of \$449,062.00. The apparent low bidder is Terry Brothers Construction Company with a bid amount of \$449,062.00. This bid amount is significantly over the FY17-18 Construction Budget due to the NCDOT requiring the project to be constructed entirely during nighttime hours. The NCDOT is also requiring a certified traffic control contractor to perform traffic control at a reported cost of \$1,500.00 per day. Staff contacted Terry Brothers to see if there were any areas to reduce costs. Terry Brothers did offer to lower the per-foot pipe cost by \$20.00, reducing the bid amount by \$23,000.00. Therefore, Terry Brothers reduced bid is \$426,062.00. In addition, a project awarded at last month's Board Meeting came in \$186,000.00 under budget and \$130,000.00 of that Budget was transferred to the Contingency Fund. \$91,062.00 will be used from the Contingency Fund to cover the overage on this project. Terry Brothers has completed numerous projects for the District and their work continues to be excellent. Staff recommends award of this contract to Terry Brothers Construction Company in the amount of \$426,062, subject to review and approval by District Counsel.

d. Consideration of Developer Constructed Sewer Systems: Asheville Area Habitat for Humanity-Beale Road; Ball Gap Road; Four Seasons Investments-Gibson Road; Monticello Apartments (aka Hawthorne at Weaverville); Newbridge Parkway Apartments; Pinnacle at Arabella Heights; Richland Street; Shelburne Drive; Somerset at Walnut Cove; White Oak (aka Cool Creek Properties):

Mr. Hartye reported that the Asheville Area Habitat for Humanity-Beale Road project included extending approximately 463 linear feet of 8-inch public gravity sewer to serve the 21 unit residential development.

Mr. Hartye reported that the Ball Gap Road Subdivision in Buncombe County included extending approximately 951 linear feet of 8-inch public gravity sewer to serve the 14 unit residential development. Minutes August 16, 2017 Page Five

> Mr. Hartye reported that the Four Seasons Investments-Gibson Road Subdivision project is located in the City of Asheville and included extending approximately 135 linear feet of 8-inch public gravity sewer to serve the 3 unit residential development.

> Mr. Hartye reported that the Monticello Apartments (aka Hawthorne at Weaverville) is located in the Town of Weaverville and included extending approximately 1,495 linear feet of 8-inch public gravity sewer to serve the 168 unit apartment complex.

Mr. Hartye reported that the Newbridge Parkway Apartments project is located in the Town of Woodfin and included extending approximately 598 linear feet of 8-inch public gravity sewer to serve the first phase of the 154 unit apartment complex.

Mr. Hartye reported that the Pinnacle at Arabella Heights project is located in Buncombe County and included extending approximately 3,907 linear feet of 8-inch public gravity sewer to serve the 65 unit residential subdivision.

Mr. Hartye reported that the Richland Street Homes project is located in the City of Asheville and included extending approximately 520 linear feet of 8-inch public gravity sewer to serve the 5 unit residential subdivision.

Mr. Hartye reported that the Shelburne Drive project is located in the City of Asheville and included extending approximately 420 linear feet of 8-inch public gravity sewer to serve the 9 unit residential subdivision.

Mr. Hartye reported that the Somerset at Walnut Cove project is located in Buncombe County and included extending approximately 432 linear feet of 8-inch public gravity sewer to serve the 5 unit residential subdivision.

Mr. Hartye reported that the White Oak (aka Cool Creek Properties) project is located in Buncombe County and included extending approximately 1,020 linear feet of 8-inch public gravity sewer to serve the 10 unit residential development.

Staff recommends acceptance of the aforementioned developer constructed sewer systems. All MSD requirements have been met.

# e. Consideration of Reimbursement Resolution for Bond Projects:

Mr. Powell reported that to be in compliance with IRS regulations concerning tax-exempt financing, all expenditures made with non-MSD bond funds and to be reimbursed from MSD bond funds must be properly identified and authorized. The proposed reimbursement resolution identifies major projects intended to be solely or substantially Minutes August 16, 2017 Page Six

> financed by bonds anticipated to be issued in FY 2023. Board approval is required to obtain the tax-exemption of interest paid on MSD bonds by authorizing reimbursement from bond proceeds of the expenditures for the attached project listing.

# f. Fourth Quarter Budget to Actual Review – FY 2017:

Mr. Powell reported that the Domestic Revenue is above budgeted expectations. Staff believes Domestic User Fee variance will end up around 103% when June accounts receivable data is received from its Member Agencies in relation to the District's audit in September. Industrial Revenue is trending better than budgeted expectations due to temporary increased revenue from one new industrial user. Facility and Tap Fees are above budgeted expectations. This is due to the District receiving \$3.7 million from 8 developments as well as the conservative nature in which these funds are budgeted. Interest and miscellaneous income are below budgeted expectations. Short-term interest rates are still experiencing pressures due to Federal Reserve monetary policy. O&M expenditures are at 96.35% of budget. This amount may vary slightly from audited numbers due to final accruals for the fiscal year. Bond principal and interest are better than budgeted expectations due to the interest rate swap associated with Series 2008A revenue refunding bonds. Capital Project expenditures are at approximately 81.89% of budget. CIP projects are continuing to receive favorable pricing.

# g. Cash Commitment/Investment Report Month ended June 30, 2017:

Mr. Powell reported that Page 72 presents the makeup of the District's Investment Portfolio. The makeup of the portfolio is substantially the same as compared to last month. Page 73 is the MSD Investment Manager report as of the month of June. The weighted average maturity of the investment portfolio is 125 days. The yield to maturity is 1.06% and is exceeding MSD bench marks of the 6 month T-Bill and NCCMT cash portfolio. Page 76 presents the MSD Variable Debt Service report for the month of July. The 2008A Series Refunding Bonds are performing better than budgeted expectations. As of the end of July this issue has saved the District rate payers approximately \$5.1 million dollars in debt service since April 2008.

# 2. Election of Officers:

Mr. VeHaun called on Mr. Clarke to preside over the election of the Chairman. Mr. Clarke called for nominations for Chairman of the MSD Board. Mr. Kelly nominated Mr. VeHaun as Chairman. Ms. Frost and Mr. Pressley seconded the nomination. Mr. Clarke called for further nominations. With no further nominations Mr. Clarke called for a motion that nominations be closed. # 9. Consolidated Motion Agenda:

# a. Consideration of Bids – Point Repair Contract No. 2:

Mr. Hartye reported that this project is comprised of various point repairs located throughout the District's service area. This contract was informally advertised and two bids were received on June 29, 2017 as follows: Terry Brothers Construction Company with a bid of \$259,000.00 and Patton Construction Group with a bid of \$215,610.00. The apparent low bidder is Patton Construction Group. Patton has

completed rehabilitation projects and sewer line extensions for the District and their work quality has been excellent. Patton was also the contractor on the previous point repair contract. The FY 17-18 Construction Budget for this project is \$250,000.00. Staff recommends award of this contract to Patton Construction Group in the amount of \$215,610.00, subject to review and approval by District Counsel.

# b. Consideration of Bids – Louisiana Avenue @ Brucemont Circle GSR:

Mr. Hartye reported that this project is located in West Asheville and is being split between the MSD construction group and a contractor. The new line is comprised of 1,420 LF of 8-inch DIP to be installed by dig and replace. An additional 1,000 LF of this line will be rehabilitated by MSD System Services, for a total project length of 2,420 LF. The contract was advertised and two bids were received on June 29, 2017. The contract was re-advertised and two bids were received on July 10, 2017 in the following amounts: Thomas Construction Company in the amount of \$498,085.00 and Terry Brothers Construction Company in the amount of \$363,252.00. The apparent low bidder is Terry Brothers Construction Company. They have completed numerous projects for MSD and their work quality continues to be good. The FY 17-18 Construction Budget for this project is \$550,000.00, with the estimate for this contracted portion to be \$370,000.00. Staff recommends award to Terry Brothers Construction Company in the amount of \$363,252.00, subject to review and approval by District Counsel.

# c. Consideration of Developer Constructed Sewer Systems: Conestee Subdivision, 880-888 Patton Avenue and Upstream Way Phase 2:

Mr. Hartye reported that the Conestee Street Subdivision project included extending approximately 107 linear feet of 8-inch public gravity sewer to serve the seven unit residential development.

Mr. Hartye reported that the 880-888 Patton Avenue project included extending approximately 86 linear feet of 8-inch public gravity sewer to better serve the commercial development.

Mr. Hartye reported the Upstream Way Phase 2 project is located off of Amboy Road and included extending approximately 398 linear feet of 8-inch public gravity sewer to serve this phase of the eleven unit residential development.

Staff recommends acceptance of the aforementioned developer constructed sewer systems. All MSD requirements have been met.

# d. Consideration of Required Resolutions to Implement 401(a) Plans:

Mr. Hartye reported that in 1996 and 2001, MSD engaged Valic Retirement Services and Nationwide Insurance to provide "Deferred Compensation" programs to its employees. When these plans were initially set up, based on outside advice, MSD did not pay the FICA on MSD's contributions. In March of 2017 MSD discovered this error and began to work to resolve the issue. An outside Counsel who specializes in Deferred Compensation and Retirement Plans recommended creating 401(a) plans with our current vendors that mirror the 457 plans. The MSD Board is requested to approve the two attached resolutions creating 401(a) Retirement Plans offered by Nationwide Insurance and Valic Retirement Services. Mr. Clarke reported that the error was probably someone relying on an attorney with one of the retirement services giving a verbal telephone opinion for MSD to not pay FICA on these deferred compensation plans. He further stated that MSD discovered this year in conversations with the State Treasurer that it was in fact required. Mr. Capwell with McQuire Woods in Charlotte specializes in this area and helped MSD fix the problem. Mr. Root asked if MSD owed a big lump sum for back pay. Mr. Hemphill stated that MSD has done what the IRS allows, which is go back for the last three years to recover as much as identified and pay them back. Mr. Hemphill stated that it came to approximately \$27,000.00. The IRS will not allow you to go back and fix everything. MSD identified their responsibility in these areas and when the employee cashes out from the plans, Staff works closely with Valic and Nationwide to identify how much is there. MSD will identify what the tax liability is and pay that tax liability. When MSD pays that tax liability, that then becomes a taxable event for the employee. All of the employees involved are aware of this. None of these employees have objected. Total cost over the life of the plan in terms of FICA and tax penalties should be less than \$100,000.00. Mr. Clarke asked how many employees are currently involved? Mr. Hemphill stated that there are 28 total employees over the years that are still active in the plan, 7 are current employees who are active in the plan. Mr. Pelly asked what amount of time that would be spread over? Mr. Hemphill stated 10-25 years but Staff does not see this as a big issue.

# e. Cash Commitment/Investment Report Month ended May 31, 2017:

Mr. Hartye reported that there is \$53 Million in the bank and the balance after this year's obligation is \$29 Million, which carries over toward construction for next year. The Investment Portfolio shows no significant change from last month. The Investment Manager's report shows no significant change. The District's Cash Receipts for Monthly and YTD domestic and industrial sewer revenue are in line with the exception of the Development Fees which are "bullish" and continue to be so. Monthly and YTD O&M expenditures are in line with the exception of the Capital Projects which are running a few months behind

on our multi-year project at the plant, which is spread over 3 fiscal years. Mr. Hartye presented the report for the 2008A Series Refunding Bonds which have saved the District's rate payers over \$5 million dollars in debt service since April 2008.

With no further discussion, Mr. VeHaun called for a motion to approve the Consolidated Motion Agenda. Mr. Pelly moved. Mr. Kelly seconded the motion. Roll call vote was as follows: 11 Ayes; 0 Nays.

Mr. Hartye reported that Status Reports are included at the end of the Board packages each month. The MSD System Services In-House Construction Report shows the 20,000 LF of projects completed each year; the Pipeline Maintenance totals show the washing, rodding, cctv'ing and smoke testing performed to meet the 500,000 LF required per year; the Customer Service Requests report shows the average response time for all calls and pointed out that the average response time is 36 minutes during normal working hours and 38 minutes after hours to any call that comes in; the Right of Way Summary shows the status of all open projects in the Right of Way Section; the Capital Improvement Program Summary reports on the larger, contracted out projects; and the Planning & Development Project Report shows the status of all active Planning and Development projects.



- WHEREAS, on May 30, 2017, the North Carolina General Assembly enacted Session Law 2017-26, Senate Bill 155, entitled "An Act to Amend the Provisions Regarding Expansion of a Metropolitan Sewerage District and to Make Additional Board Appointments Parallel to the Process to Expand a Metropolitan Water and Sewerage District; and
- WHEREAS, the said Act revises N.C. General Statute §162A-68 to now provide for inclusion of a part of a political subdivision (and not just the whole) into a Metropolitan Sewerage District; and
- WHEREAS, the County's Cane Creek sewer system, limited to the Cane Creek Water and Sewer District, is served for sewage treatment purposes by the Metropolitan Sewerage District of Buncombe County's treatment plant; and
- WHEREAS, inclusion of the Cane Creek sewer system into the Metropolitan Sewerage District of Buncombe County would result in substantially lower fees for customers of the Cane Creek system, while maintaining high levels of service;
- NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Henderson County, North Carolina, that the Board hereby formally requests the inclusion, for the purpose of sanitary sewer service, into the Metropolitan Sewerage District of Buncombe County all the territory included in the County's existing Cane Creek Water and Sewer District.

# MSD-CCWSD Merger Process Summary

# As defined by NCGS 162A-68


- 1) The Henderson County Commissioners file a resolution with the District Board requesting inclusion of CCWSD into the District.
- 2) The District Board may accept or reject this request. If accepted, then:
- 3) The District Board notifies the Buncombe County and Henderson County Commissioners of the intended action.
- 4) The District Board files a report with both Commissions and the Environmental Management Commission (EMC) describing the process/plans for extending service to the new area.

The report shall include: a) Maps of the District and adjacent territory showing present and proposed boundaries, existing and proposed interceptors.

- b) A statement by the District for extending services into the new area, which addresses:
  - 1) Extension of services into the new territory.
  - 2) A proposed time schedule.
  - Costs of extending service and methods to fund these costs, the amount of outstanding indebtedness of the District, and the valuation of assessable properties within the District and the new territory.
  - 4) A Declaration of Intent of District Board to conform with the plans set forth in the report, and a certification by the District Board Chairman that the "matters and things" in the report are true to his knowledge or belief.
- 5) The Chairmen of the Boards of Commissioners request that a representative from the EMC hold a joint public hearing with the Boards of Commissioners.

The hearing shall be within the District, a 30 day notice shall be posted on the courthouse door of both counties, and noticed in the paper for each of four successive weeks prior to (at least 30 days prior).

- 6) After the hearing and upon favorable opinion by the EMC and the Boards of Commissioners, the EMC adopts a resolution to the same effect. The EMC resolution defines the new boundary and declares that the new area is included within the District.
- 7) Notice of the EMC's resolution shall be published in accordance with NCGS 162A-66.
- 8) New Board members are appointed by the Henderson County Commissioners. In accordance with HB764, three new members will be appointed. They must be qualified voters residing within the new territory.
- Not shown above: 1) Provisions in the statute which allow for voters within CCWSD to petition the District Board for inclusion.
  - 2) Provisions in the statute which allow for a petition signed by 10% of the voters *within the District* to require an election to decide. This must occur prior to (or at) the public hearing.
  - 3) Court actions to set aside a resolution of the EMC.
  - 4) Definitions of new District Board members' term limits.

# Get costs, input on sewer deal

hy would Henderson County want to get back into the sewer business by taking over a private sewage system in Etowah, just as it is preparing to hand off its Cane Creek Sewer District to a regional authority?

This is one of several questions raised by the Board of Commissioners' unanimous vote Wednesday to block Hendersonville from buying the Etowah Sewer Co. for \$1 million.

The city must seek county approval for any extension of its sewer system as part of a 2000 city/ county agreement that ended a long series of disputes and litigation.

Hendersonville announced a year ago that it had reached an agreement to buy the system and has since gotten approval from the N.C. Utilities Commission as required for the sale to proceed.

At Wednesday's meeting, Commissioner Bill Lapsley gave a detailed presentation on the history of the Etowah sewer system. Lapsley served as a consulting engineer when the system was built 30 years ago. Developers and homebuilders established the privately owned public utility, which now serves 372 residential customers and 42 business customers.

Lapsley says Henderson County has a vested interest in seeing the system continue operation and "allow for growth in the unincorporated part of Etowah." He said the city should not control growth in an unincorporated part of the county, and that Etowah customers would not be able to hold Hendersonville City Council accountable for policies and rates if the city buys the system. He proposed that the county offer to take all of the Etowah Sewer Co.'s assets "at no cost to the county taxpayer."

The city for years has agreed to follow county land-use plans in deciding where to extend utilities. City Manager John Connet says that would not change if the city were to own and operate the system.

The Etowah Sewer Co. asked the city to take over the system a year ago, outlining about \$500,000 in needed repairs. The company estimates it would have to raise monthly fees from \$26.33 to between \$43 and \$45 if it has to make the improvements.

Lapsley's presentation is the latest salvo in a dispute over who will control water and sewer extensions in the county. Commissioners on Wednesday also passed a resolution formally asking that the Cane Creek sewer system be included in the Metropolitan Sewerage District of Buncombe County, a move expected to cut rates by 30 percent for 4,000 customers.

Back in 2000, county leaders happily divested themselves of the moneydraining Mud Creek sewage system, selling it to Hendersonville for \$449,185 in a move that also cut rates.

It's not clear how the county would take over the Etowah system "at no cost to the taxpayers" when the system faces a half-million dollars in needed repairs, and after the city has agreed to pay \$1 million to its owners. If the county plans to turn over the system to MSD, that needs to be disclosed and discussed.

Customers deserve a say, and county taxpayers deserve to know all the costs involved.

- **BACKGROUND:** All wastewater treatment plants are required to disinfect plant effluent prior to discharging treated wastewater to a waterbody. MSD utilizes sodium hypochlorite (aka bleach) for this purpose.

Previously, chlorine gas was utilized for disinfection; however, it is highly toxic and due to its hazardous nature MSD converted to sodium hypochlorite disinfection in 2002. The current system utilizes four tanks, each with a volume of 15,000 gallons.

Sodium hypochlorite is an aggressive chemical, and the tanks used to store it have been repaired multiple times due to slow leaks. They are now past their functional lifespan and must be replaced.

Staff obtained quotes from two regional companies which manufacture chemical storage tanks, as follows:

# Manufacturer Proposal Amount with Delivery

1) Southeastern Fiberglass Products\$ 118,000.002) Augusta Fiberglass\$ 94,658.00

The prices above are for four 15,000 gallon tanks, and include delivery to the plant. Removal/disposal of the old tanks and installation of these new tanks will be performed by a contractor. Sufficient funds for the installation work have been included in the FY17-18 project budget.

Please refer to the attached documentation for further details.

- **FISCAL IMPACT:** The FY17-18 Construction Budget for this project is \$183,000.00, which also includes funds for the removal of the old tanks and installation of the new tanks.
- **STAFF RECOMMENDATION:** Staff recommends award of this equipment procurement to Augusta Fiberglass in the amount of \$94,658.00, subject to review and approval by District Counsel.

# RE: Sodium Hypochlorite Storage Tank Replacement, MSD Project No. 2017016

Sodium hypochlorite (the active ingredient found in commercial liquid bleach) is used at the Water Reclamation Facility to disinfect treated wastewater prior to leaving the facility. The plant doses sodium hypochlorite at a rate of approximately 60 gal/MG treated wastewater and has four large storage tanks, each with a capacity of 15,000 gallons. Product is delivered to the plant at 12.5% solution and diluted for storage to 6.25% using potable water.

The existing sodium hypochlorite storage tanks were placed into service in 2002 when the plant converted from gaseous chlorine to liquid sodium hypochlorite as its primary disinfectant. The tanks are constructed of fiberglass reinforced plastic (FRP) and have a life expectancy of 10-15 years. Over the past two years, plant staff has periodically observed areas at the base of the tanks that have thinned and begun to seep due to the aggressive nature of sodium hypochlorite. Repairs have been made on site by the manufacturer on several occasions.

Having exceeded the manufacturer's recommended life expectancy and having experienced leakage from the tanks, MSD solicited informal proposals for replacement tanks. Quotes were received from two vendors for four (4) FRP 15,000 gallon tanks suitable for storing 12.5% sodium hypochlorite solution. Proposal amounts were as follows:

The FY 17/18 budget amount for this project is \$183,000.00 which also includes removal of the existing tanks and installation of new tanks.

Staff recommends that the District move forward with procurement of four replacement sodium hypochlorite storage tanks contingent upon review and approval by District Counsel.



- **BACKGROUND:** The Rotating Biological Contactors (RBC's) perform the biological treatment process at the plant. They utilize a large volume of low pressure air, provided by blowers, to make them rotate.

The blowers were replaced in 2008 and continue to function properly. The starters, however, were originally installed in 1988 and are now in need of replacement. The replacement units will be "soft starters" which help reduce both startup current and stress on the motors when they cycle on and off.

Staff obtained quotes from two manufacturers of equipment:

# Manufacturer Proposal Amount

1) Rockwell Automation/Allen-Bradley	\$209,872.00
2) Eaton	\$202,000.00

Eaton is a manufacturer of quality equipment; and their equipment is utilized at other locations at the plant. Further, they are a local manufacturer based nearby in Arden, N.C. which is beneficial for service and parts availability.

Funds for the installation work have been included in the FY17-18 project budget.

Please refer to the attached documentation for further details.

- **FISCAL IMPACT:** The FY17-18 Construction Budget for this project is \$375,000.00, which also includes costs for ancillary equipment and installation.
- **STAFF RECOMMENDATION:** Staff recommends award of this equipment procurement to Eaton in the amount of \$202,000.00, subject to review and approval by District Counsel.

Supplying diffused air to the RBCs is perhaps the most important mechanical process at the Water Reclamation Facility. The RBCs are air-driven and rely entirely on diffusers mounted on the bottom of the RBC basins for rotation. Without an air supply, the units would be unable to rotate and the plant's biological process would fail. In addition to supplying air to the RBC air cups, the diffusers create a highly aerobic environment in the wastewater that enables the RBC fixed-film growth to sorb an even greater amount of organic material.

Diffused air is supplied by five large, 450 HP blowers located centrally on the plant campus. The existing motor controllers/starters were installed during the 1988 plant upgrade and are now obsolete, making part replacement difficult. Each blower motor is fed directly from the plant's main switchgear with 2400V power. The existing "across-the-line" motor starters consume an incredible amount of inrush current at start-up (up to 10 times higher than running current) and also produce high torque conditions, both of which create stress on the motor and blower drive shaft.

MSD staff recommend replacing the existing motor controllers/starters with soft-start controllers. These devices reduce the current and torque during starting and accelerate the equipment smoothly, leading to longer service life and reduced stress on the power supply and mechanical equipment.

MSD solicited proposals for five (5) 2400V, 450HP soft starters from two preferred manufacturers. Proposal amounts were as follows:

1) Rockwell Automation/Allen-Bradley	\$209,872.00
2) Eaton	<b>\$202,000.00</b>

The District is familiar with Eaton electrical gear after having installed various units at the Water Reclamation Facility and Carrier Bridge Pump Station. Staff has been very pleased with its performance, parts availability (manufactured in Arden, NC), and technical service response.

The FY 17/18 budget for this project is \$375,000.00 which also includes a new 2400V/480V transformer and 480V power distribution panel (quoted at \$44,500), and installation of all new equipment (quoted at \$109,800).

Staff recommends that the District move forward with the procurement of five Eaton soft-start controllers contingent upon review and approval by District legal counsel.



- **BACKGROUND:** This project is located in South Asheville along Hendersonville Road, in front of the Walmart store.

It consists of replacing a problematic six-inch clay line in poor condition and a six-inch DIP road crossing, both of which are undersized for current flows. The new line is comprised of 1,150 LF of 8-inch DIP, installed by dig & replace.

The contract was informally advertised and two bids were received on July 27, 2017 in the following amounts:

#### Contractor Bid Amount

1) Thomas Construction Co.\$486,400.002) Terry Brothers Construction Co.\$449,062.00

The apparent low bidder is Terry Brothers Construction Co. with a bid amount of \$449,062.00. This amount is \$114,062.00 over the FY17-18 construction budget of \$335,000.00.

As allowed by NCGS 143-129(b) staff contacted Terry Brothers to see if there were any areas to reduce costs. A significant factor for the overage is that NCDOT is requiring the project to be constructed entirely during nighttime hours, and is also requiring a certified traffic control contractor to perform the traffic control - at a reported cost of \$1,500 per day.

Terry Brothers did offer to lower the per-foot pipe cost by \$20, which amounts to a net bid reduction of \$23,000.00. Terry Brothers' reduced bid is therefore **\$426,062.00**. In addition, the Louisianna @ Brucemont project (awarded at the July 2017 Board meeting) was \$186,000 under budget - \$130,000 of which was transferred to the Contingency Fund.

Terry Brothers has completed numerous MSD sewer rehabilitation projects, and their work quality continues to be excellent on work performed for the District.

Please refer to the attached documentation for further details.

- **FISCAL IMPACT:** The FY17-18 Construction Budget for this project is \$335,000.00. There are sufficient funds in the CIP Contingency for the overage of \$91,062.00.
- **STAFF RECOMMENDATION:** Staff recommends award of this contract to Terry Brothers Construction Co. in the amount of \$426,062.00, subject to review and approval by District Counsel.



The Hendersonville Road @ Peachtree Road Sewer Rehabilitation project is located in South Asheville along Hendersonville Road. This project begins with connecting to an existing manhole at Peachtree Road, runs along the outer northbound lane of Hendersonville Road, and then crosses Hendersonville Road to reconnect to an existing system at the Racquet Club Condominium development.

This project consists of the rehabilitation of existing 6" VCP and 6" DIP sewer lines that are in poor condition and undersized. Approximately 1,150 LF of 8" DIP will be installed by dig and replace construction. The existing lines for this project have a Pipe Rating of 56 due to the under sizing and poor condition of the clay pipes.

On July 27, 2017, two (2) bids were received at 2:00 pm. Results were as follows:

#### **Background**

To be in compliance with IRS regulations concerning tax-exempt financing, all expenditures made with non-MSD bonds funds and to be reimbursed from MSD bond funds must be properly identified and authorized. The proposed reimbursement resolution identifies a major project intended to be solely or substantially financed by bonds anticipated to be issued in FY 2023. Board approval is required to obtain the tax-exemption of interest paid on MSD bonds by authorizing reimbursement from bond proceeds of the expenditures for this project.

This resolution does not take the place of an annual budget or capital projects ordinance as mandated by North Carolina General Statutes required authorizing any expenditures irrespective of source of the funds. The project has been or will be included in the District's annual budget process.

In addition to this current reimbursement resolution, additional resolutions may be submitted for other projects when their anticipated costs may be more accurately projected.

#### **Discussion**

\$28 million of bonds are planned to be issued in FY 2023, and this reimbursement resolution is intended to preserve for the District the ability to issue the bonds as tax-exempt bonds and to reimburse itself from their proceeds for the temporary cash outlay made for the projects identified in the reimbursement resolutions.

Engineering Staff have identified several upcoming projects detailed on the attached exhibit, which could be reimbursed from the upcoming revenue bonds. Estimated reimbursable expenditures for these projects total \$9,762,000.

# **REIMBURSEMENT RESOLUTION**

RESOLUTION OF THE DISTRICT BOARD OF THE METROPOLITAN SEWERAGE DISTRICT OF BUNCOMBE COUNTY, NORTH CAROLINA DECLARING ITS INTENTION TO REIMBURSE ITSELF FROM THE PROCEEDS OF ONE OR MORE TAX-EXEMPT FINANCINGS FOR CERTAIN EXPENDITURES MADE AND/OR TO BE MADE IN CONNECTION WITH THE ACQUISITION, CONSTRUCTION AND/OR EQUIPPING OF CERTAIN CAPITAL IMPROVEMENTS

WHEREAS, the Metropolitan Sewerage District of Buncombe County, North Carolina (the "Issuer") is a body politic and corporate organized and existing under the laws of the State of North Carolina; and

WHEREAS, the Issuer has paid, beginning June 16, 2017, and will pay, on and after the date hereof, certain expenditures (the "Expenditures) in connection with the acquisition, design and construction of the projects on the attached Exhibit (the "Projects"); and

WHEREAS, the District Board of the Issuer (the "Board") has determined that those monies previously advanced no more than 60 days prior to the date hereof and to be advanced on and after the date hereof to pay the Expenditures are available only for a temporary period and it is necessary to reimburse the Issuer for the Expenditures from the proceeds of one or more issues of tax-exempt bonds (the "Bonds");

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD AS FOLLOWS:

**Section 1.** The Board hereby declares the Issuer's intent to reimburse the Issuer with the proceeds of the Bonds for the Expenditures with respect to the Project made on and after June 16, 2017 which date is no more than 60 days prior to the date hereof. The Issuer reasonably expects on the date hereof that it will reimburse the Expenditures with the proceeds of the Bonds.

**Section 2.** Each Expenditure was and will be either (a) of a type properly chargeable to capital account under general federal income tax principles (determined in each case as of the date of the Expenditure), (b) a cost of issuance with respect to the Bonds, (c) a nonrecurring item that is not customarily payable from current revenues, or (d) a grant to a party that is not related to or an agent of the Issuer so long as such grant does not impose any obligation or condition (directly or indirectly) to repay any amount to or for the benefit of the Issuer.

**Section 3.** The maximum principal amount of the Bonds expected to be issued for the Projects is \$9,762,000.

**Section 4.** The Issuer will make a reimbursement allocation, which is a written allocation by the Issuer that evidences the Issuer's use of proceeds of the Bonds to reimburse an Expenditure, no later than 18 months after the later of the date on which the Expenditure is paid or the Projects are placed in service or abandoned, but in no event more than three years after the date on which the Expenditure is paid. The Issuer recognizes that exceptions are available for certain "preliminary expenditures," costs of issuance, certain <u>de minimis</u> amounts, expenditures by "small issuers" (based on the year of issuance and not the year of expenditure) and expenditures for construction projects of at least five years.

Section 5. This resolution shall take effect immediately upon its passage.

# **Background**

At the end of each quarter, actual revenue and expenditure amounts are compared with the budget to evaluate performance. This information is based on cash revenues and invoices received prior to June 30, 2017 and may not include some accruals of revenue and expenditures.

## **Discussion**

There are several explanatory notes at the bottom of the attached Budget to Actual schedule. Other considerations are as follows:

- Domestic revenues are at budgeted expectations. Staff believes Domestic User Fee variance will end up around 103% when June accounts receivable data is received from the Member Agencies in September. Industrial Revenue is trending better than budgeted expectations due to temporary increased revenue from one new industrial user. Staff monitors consumption trends as they have a direct effect on the District's current and future revenue projections.
- Facility and Tap Fees are budgeted conservatively. The unusually large variance as of the end of the year is due to receiving unanticipated revenue of \$3.7 million from eight developments.
- Interest and miscellaneous income are at budgeted expectations. Short-term interest rates are still experiencing pressures due to Federal Reserve monetary policy.
- > Rental income is at budgeted expectations.
- Actual and encumbered O&M expenditures are considered reasonable, but may vary slightly once accruals and adjustments are made in connection to the final audit.
- Bond principal and interest are better than budgeted expectations due to the interest rate swap associated with Series 2008A revenue refunding bonds.
- Capital project expenditures are at approximately 81.9% of budget. This reflects the delay of the Plant Headworks project.






#### METROPOLITAN SEWERAGE DISTRICT ANALYSIS OF CASH RECEIPTS As of June 30, 2017


