#### BOARD OF THE METROPOLITAN SEWERAGE DISTRICT March 20, 2019

#### 1. Call to Order and Roll Call:

The regular monthly meeting of the Metropolitan Sewerage District Board was held in the Boardroom of MSD's Administration building at 2pm Wednesday, March 20, 2019. Chairman VeHaun presided with the following members present: Ashley, Bryson, Kelly, Manheimer, Pelly, Watts, Whitesides and Wisler. Holland, Pressley and Valois were absent.

Others present were: Thomas E. Hartye, PE, General Manager; William Clarke, General Counsel; Ed Bradford, Mike Stamey, Hunter Carson, Peter Weed, Scott Powell, Jim Hemphill, Ken Stines, Spencer Nay and Sheila Kilby, MSD.

#### 2. Inquiry as to Conflict of Interest:

Mr. VeHaun asked if there were any conflicts of interest with the agenda items. No conflicts were reported.

#### 3. Approval of Minutes of the February 20, 2019 Board Meeting:

Mr. VeHaun asked if there were any changes to the Minutes of the February 20, 2019 Board Meeting. Mr. Watts moved for approval of the minutes as presented. Mr. Pelly seconded the motion. Voice vote in favor of the motion was unanimous.

#### 4. Discussion and Adjustment of Agenda:

None

#### 5. Informal Discussion and Public Comment:

There was no discussion or public comment.

#### 6. Report of General Manager:

Mr. Hartye reported that Ed Bradford and Mike Stamey will give a brief update of MSD's ongoing construction. This year's budget is approximately \$23.5 Million but the upcoming ten-year CIP budget is between \$310 - \$330 Million.

Mr. Bradford reported first on Plant Headworks projects. The old bar screens at the head of the plant have been replaced with new screens with closer spacing; new fine screens have been added and there is now a Vortex grit removal system which replaced the old Schreiber system. There was also a surge system added to handle peak flow conditions. This project was awarded by the Board in January 2017 with a project cost of around \$9.6 Million. The project began in Spring of 2017 and is currently at the completion stage. He presented a slide of the influent pump station and stated that all wastewater that MSD treats comes through this facility. He presented a video of the new fine screens in action, control panels and slides of the old digesters

that were re-purposed to be used for a storm surge. He also presented a slide of the demolition of the old Schreiber system.

The Plant High Rate Primary Treatment is a large project that has just started. There is no primary treatment right now after screening and grit removal. This was a tight fit with site restrictions at the plant and the way the topography lays. This project will help the downstream RBC's to work better and the plant can better adjust for peak flow, as you can ramp this process up and down. This project was awarded by the Board at the October 2018 Board Meeting with a construction cost of a little over \$15 million. Completion is expected by early 2021. Both projects combined will significantly improve the treatment process and will very importantly prepare the plant for future permitting requirements. He then presented slides and explained some smaller projects completed over the last year including the blower building and motor control center replacement, the intermediate clarifier slide gate replacement and the sodium hypochloride facility. He presented a graph showing capital investment, about 20 years' worth, at the plant. This is about \$62 Million worth of work.

Mr. Stamey first presented some slides of work on the South French Broad Interceptor Lining Project on the Biltmore Estate. This project is located on the river between Antler Hill Village and the Biltmore House. The existing interceptor on this project is a 36" concrete pipe which has had some deterioration and other issues. This project is being lined with a cured in place liner right at 5,111 linear feet. The project also consisted of rehabilitating 18 existing manholes and adding one manhole for future access. The Contractor for this work is Granite Inliner, LLC, based out of Gastonia. Completion is anticipated by April 1, 2019. The estimated cost of this work is approximately \$1 million. Ms. Manheimer asked if this was done in lieu of replacing the line. Mr. Hartye stated that, in this particular situation, MSD is currently designing a relief interceptor for future service requiring a larger line. This existing 36" line was structurally good enough to line so that we could minimize the size of the second line (relief interceptor) which will parallel this one.

Mr. Stamey also presented slides of the work in North Asheville on Dry Ridge Road which consisted of replacing approximately 907 linear feet of existing 8" line up a steep mountainside. The Contractor for this project is Buckeye Bridge Construction and the estimated cost is \$283,000.00. There was heavy vegetation in the right of way area on this project so there was a large amount of clearing. There were property owner concerns to be dealt with during the easement process which required Mr. Clarke's assistance, along with poor rock and soil conditions. Also, the heavy rains have caused storm drain and high ground water issues. Ms. Manheimer asked about a complaint from an owner who purchased property on this project after the easement was obtained and before construction. The Owner was not made aware of project from the Seller. Mr. Clarke stated that he and Staff have dealt with this owner and her lawyers extensively. She is really mad at the people who sold her the property. Ms. Manheimer asked if we were obligated once the property changes owners, not legally, but as a good will practice. Mr. Clarke stated that

both of her lawyers have acknowledged that MSD is well within its rights. Mr. Clarke stated that there was a very thorough notification process before construction, and if someone inspected the title for the property it is very clear that the easement is there. This easement was recorded within the last year. He stated that MSD Staff did a good job and worked through the process. Mr. Stamey stated that before construction begins, Staff sends out letters and notices, basically everything that can be done to notify property owners is done. Mr. Bradford stated that this has happened three times that he was aware of where a seller has not disclosed this information. Ms. Manheimer asked what was at the top of this project to require going to the top of the mountain. Mr. Stamey stated there were three or four houses up there. Mr. Bradford stated that it was a public system the District inherited. Ms. Manheimer asked how much this project cost. Mr. Stamey stated \$283,000.00. Mr. Stamey stated that there were 3 upcoming projects: Long Shoals Road @ Allen Avenue, Greenbriar Road in Haw Creek and Springdale Road in Kenilworth.

Mr. Stamey presented slides and reported on upcoming in-house construction projects. The 26 Wilshire Drive project is located in West Asheville and consists of replacing 1,862 feet of 8" line. This work started in February and hope to be complete by the first of April. The Weaverville Force Main project consisted of making 3 significant repairs in the last few months. One repair was made back in July, one in August and another in November with additional work to be performed in the future. The existing sewerline is 12" ductile iron pipe in very poor condition that has been in operation for over 30 years and the gases and the corrosive environment from the pumping system in Weaverville is causing it to become brittle. The Waightstill Mountain Force Main Replacement project is in South Asheville primarily along Ledbetter Road and consists of replacing 3,700 linear feet of force main. The 15 Dew Waite Road project is located in Ridgecrest and consists of 535 linear feet of 8" sewerline.

Mr. Hartye stated that Ms. Manheimer brought up a good point regarding the cost of a line for just a few houses. The dynamic is different than what you have with the water systems. With the sewer system if it leaks no matter how much it costs, if it hits a stream, MSD will get an NOV and it becomes a big deal. With the water system it's a little different. MSD is driven by any event of leakage coming out of the pipes regardless of the cost to repair.

Mr. Hartye reported that Jute of Clasique Acupuncture e-mailed to thank Gilbert Karn, Roy Lytle and crew.

Mr. Hartye reported that attached are some cards of appreciation from Koontz Intermediate School. He stated that one of his favorite's was "We learned some really cool stuff, some really interesting things, and some really nasty stuff".

Mr. Hartye reported that the next Right of Way Committee meeting will be held on March 27, 2019 at 9 am. The next Regular Board Meeting will be held on April 17, 2019 at 2 pm.

#### 7. Consolidated Motion Agenda:

## a. Consideration of Developer Constructed Sewer Systems: The Peaks; Hunt Hill Apartments:

Mr. Hartye reported that the Peaks project is located off South Tunnel Road in the City of Asheville and consisted of extending approximately 690 linear feet of 8-inch public gravity sewer to serve a commercial development.

Mr. Hartye reported that the Retreat at Hunt Hill Apartments project is located in the City of Asheville and consisted of extending approximately 1,735 linear feet of 8-inch public gravity sewer to serve the 180-unit apartment complex.

Staff recommends acceptance of the aforementioned developer constructed sewer system. All MSD requirements have been met.

#### b. Cash Commitment/Investment Report Month ended January, 2019:

Mr. Powell reported that Page 27 presents the makeup of the District's Investment Portfolio. There has been no significant change in the makeup of the portfolio from the prior month. Page 28 presents the MSD investment managers report for the month of January. The weighted average maturity of the investment portfolio is 251 days. The yield to maturity is 2.55%. Page 29 presents the MSD analysis of Cash Receipts. Domestic User Fees are considered reasonable based on the timing of cash receipts and historical trends. Industrial User Fees are considered reasonable taking into consideration a temporary increase in revenue from one industrial user. Facility and Tap Fees are above budgeted expectations due to receiving \$1.2 million from two developers. Page 30 presents the MSD analysis of Expenditures. O&M, Debt Service and Capital Project expenditures are considered reasonable based on historical trends and timing of capital projects. Page 31 presents the MSD Variable Debt Service report. The 2008A Series is performing at budgeted expectations. As of the end of February this issue has saved the District rate payers approximately \$5.8 million in debt service since April of 2008.

With no further discussion, Mr. VeHaun called for a motion to approve the Consolidated Motion Agenda. Mr. Pelly moved. Ms. Bryson seconded the motion. Roll call vote was as follows: 9 Ayes; 0 Nays.

#### BOARD OF THE METROPOLITAN SEWERAGE DISTRICT February 20, 2019

#### 1. Call to Order and Roll Call:

The regular monthly meeting of the Metropolitan Sewerage District Board was held in the Boardroom of MSD's Administration building at 2pm Wednesday, February 20, 2019. Chairman VeHaun presided with the following members present: Ashley, Bryson, Holland, Kelly, Manheimer, Pelly, Pressley, Valois, Watts, Whitesides and Wisler.

Others present were: Thomas E. Hartye, PE, General Manager; William Clarke, General Counsel; Forrest Westall with McGill Associates; Joseph Martin with Woodfin Sanitary Water & Sewer District; Ed Bradford, Mike Stamey, Peter Weed, Roger Edwards, Scott Powell, Jim Hemphill, Ken Stines, Spencer Nay and Pam Nolan, MSD.

#### 2. Inquiry as to Conflict of Interest:

Mr. VeHaun asked if there were any conflicts of interest with the agenda items. No conflicts were reported.

#### 3. Approval of Minutes of the January 16, 2019 Board Meeting:

Mr. VeHaun asked if there were any changes to the Minutes of the January 16, 2019 Board Meeting. Mr. Watts moved for approval of the minutes as presented. Mr. Pressley seconded the motion. Voice vote in favor of the motion was unanimous.

#### 4. Discussion and Adjustment of Agenda:

None

#### 5. Informal Discussion and Public Comment:

Mr. VeHaun welcomed Mr. Martin with Woodfin Sanitary Water and Sewer District. There was no discussion or public comment.

#### 6. Report of General Manager:

Mr. Hartye gave an update on the plant bypass and new treatment system. He reported that this may have been one of the busiest two weeks in the last 20 years. He presented slides and explained the emergency by-pass system, which by-passes entire front of the plant to allow for the critical tieins to be made. During the process of getting ready to start the by-pass pumps yesterday, the Contractor dug down to inspect the connection and there was a leak. The by-pass had to be started immediately but luckily they missed the worst of the rain and everything worked out well. He stated that he would go into more detail next month.

Mr. Hartye reported that during one of System Services periodic inspections of the interceptors along the river, one of the employees discovered a joint nearly opened up but it had not yet started leaking. This was

> an emergency situation that required pumps to be set up. He presented slides of the interceptors and the work performed to repair the problem. He explained that these are 2 twin interceptors, one an older 36" line, along the Swannanoa River. These lines were immediately adjacent to the retaining wall supporting the railroad tracks. Engineering employees surveyed the line and Mr. Bradford designed a strong back of two beams. Mr. Hartye thanked Ken Stines and his crew and Ed Bradford and Engineering for their quick reaction. Mike Stamey was also very instrumental in making this whole project work by getting up with the Norfolk Southern track supervisor and Duke Power to make them understand what we were contending with. Norfolk Southern basically shut down the closest series of tracks so that a crane could be brought in and the beams could be placed. Duke Power had to shut off the lower transmission lines. The beams were then welded together, and the joints of the failing interceptor were chained so they won't fall any further. The piers supporting the sewer lines have been washed away by the river and this is a temporary repair to keep it from failing and getting into the river. It will still need to be lined on the inside now that it is secure. The ultimate goal somewhere in the future is to replace both lines with one 60" line. Mr. Hartye again thanked Ed Bradford, Ken Stines and Mike Stamey and their Staff. He stated that luckily the employee saw it before it became a gusher in the middle of the river. Mr. VeHaun asked how much the temporary repair cost. Mr. Bradford stated that it was about \$80,000.00. This included the contractor, beams and mobilizing the crane. Mr. Hartye added that Ken's folks cost about another \$40,000.00 and that there will still be more spent on lining (approximately \$140,000.00), the interceptor until it can be replaced. Total repair at about ¼ million.

> Mr. Hartye thanked Lisa Tolley and Angel McCrain for running the MSD Booths to provide information and education at the Build and Remodel Expo (which saw approximately 4,000 people).

Mr. Hartye reported that RL Ellinburg of Black Mountain called to express his appreciation for the service provided by Grady Brooks who was courteous, helpful and did a wonderful job.

Mr. Hartye reported that Steve Heflin at 6 Imperial Court called to say that he was impressed with Pete Cole and Wayne Rice and their quick response time and how helpful they were.

Mr. Hartye thanked Roger Edwards for heading up the plant tours this year even amidst the extensive construction at the plant. Attached is a list of tours and number of attendees for this year which was very aggressive, about 620 attendees.

Mr. Hartye reported that attached is an article in the ACT regarding brewery waste and the impacts that it may have on public treatment works. The article was a bit confusing as it kept switching back and forth between MSD and Brevard and our experiences are quite a bit different. What was not

mentioned was that MSD has a pretreatment group that manages all the significant industrial waste and has met frequently with the Brewers Alliance to educate them on how to mitigate waste impacts by side-stream separation, disposal, etc. MSD allowed New Belgium to temporarily discharge under certain permitted conditions while they constructed their pretreatment system. The larger breweries need to pretreat at their campus before they discharge to MSD. This was a win-win that was worked out with them. It was a very heavy financial outlay at the very beginning and they wanted a couple of years to put it on line. MSD had available capacity and allowed them to discharge a little higher strength waste on a temporary basis with permit limits and conditions. Just the extra strength portion over about 2 ½ years was about \$835,000.00 that MSD received from New Belgium which helps a lot for the improvements being done at the plant. MSD has regained that capacity now that New Belgium's pretreatment is on line.

Mr. Hartye reported the next Regular Board Meeting will be held on March 20, 2019 at 2 pm. The next Right of Way Committee meeting will be held on March 27, 2019 at 9 am.

#### 7. Consolidated Motion Agenda:

## a. Consideration of Bids: Long Shoals Road @ Allen Avenue Sanitary Sewer Rehabilitation Project:

Mr. Hartye reported that this project is in South Asheville near Long Shoals Road and Hendersonville Road and abuts the TC Roberson High School property. The line is in poor structural condition. Portions of the line have already been rehabilitated so this is a very small contract consisting of 458 LF. The contract was advertised and five bids were received on January 31, 2019 as follows: Thomas Construction Company in the amount of \$222,798.00; North American Pipeline Management in the amount of \$135,420.00; Buckeye Bridge LLC in the amount of \$135,322.00; Terry Brothers Construction Company in the amount of \$128,310.00 and Teraflex Group LLC in the amount of \$112,321.00. The apparent low bidder is Teraflex Group LLC with a bid amount of \$112,321.00. Teraflex has not previously done work for the District. Staff checked their references and they were very complimentary. The FY18-19 Construction Budget for this project is \$184,000.00. Staff recommends award of this contract to Teraflex Group LLC in the amount of \$112,321.00, subject to review and approval by District Counsel.

# b. Consideration of Cost Participation: 17 North Market Street Development:

Mr. Hartye reported that this project is located in downtown Asheville between North Market Street and Langren Alley. It is a retrofit of an existing building with 16 new condominiums. The MSD line in Langren Alley which serves this project was previously identified as a Capital Improvement Project due to the condition of the old 6-inch clay line. MSD

> staff has evaluated the project under our cost participation and there is an attached worksheet reflecting that they are eligible for 100% reimbursement. The cost estimate based on current bid pricing for MSD projects of similar scope is \$86,685.37. If the timing of it should be that they could finish before July 1, 2019, the funds will come out of CIP Contingency for this year. Should the actual timing of the project result in reimbursement likely to occur in FY 19-20, this reimbursement will be formally budgeted for next fiscal year. This item will be brought back before the Board for approval of actual cost upon completion. Ms. Manheimer asked if this would be a conflict of interest for her since it is located next to her law firm. Mr. Clarke stated that he did not believe it was a conflict. Staff recommends that the Board approve a reimbursement of \$86,685.37 to Spectrum Building Company Inc., contingent upon full completion of the sewer rehabilitation portion of their project. No payment shall be issued until the sewer is installed to MSD Standards and Specifications, all final paperwork is received including any easement conveyance, and the system is fully accepted by this Board.

c. Consideration of Developer Constructed Sewer Systems: Cisco Road Homes; Asheville Habitat – Curry Court (Affordable Housing Reimbursement); 605 Fairview Road; Grindstaff Subdivision; Maple Trace Phase 2; Villa Heights:

Mr. Hartye reported that the Cisco Road Homes project is located in the City of Asheville and consisted of extending approximately 168 linear feet of 8-inch public gravity sewer to serve a 7-lot single family residential development.

Mr. Hartye reported that the Asheville Habitat – Curry Court (Affordable Housing Reimbursement) project consisted of extending approximately 554 linear feet of 8-inch public gravity sewer to serve the 12-unit affordable housing development. This project also qualifies for the District's Cost Recovery Reimbursement for the lesser value of either the construction of the sewer extension or five years' estimated revenue. Attached is the calculation of the estimated five years' revenue. The estimated revenue is \$14,656.00. Staff recommends acceptance of this developer constructed sewer system and to authorize General Manager to disburse \$14,656.00 to Asheville Area Habitat for Humanity, Inc.

Mr. Hartye reported that the 605 Fairview Road project included extending approximately 362 linear feet of 8-inch public gravity sewer to serve the 6-lot single family residential development.

Mr. Hartye reported that the Grindstaff Subdivision project included extending approximately 110 linear feet of 8-inch public gravity sewer to serve the 5-lot single family residential development.

Mr. Hartye reported that the Maple Trace Phase 2 project is located in the Town of Weaverville and included extending approximately 2,560 Minutes February 20, 2019 Page Five

linear feet of 8-inch public gravity sewer to serve the 37-lot single family residential development.

Mr. Hartye reported that the Villa Heights project is located in the City of Asheville and included extending approximately 548 linear feet of 8-inch public gravity sewer to serve the 8-lot single family residential.

Staff recommends acceptance of the aforementioned developer constructed sewer system. All MSD requirements have been met.

#### d. Second Quarter Budget to Actual FY19:

Mr. Powell reported that Page 42 presents the District's Second Quarter Budget to Actual Review and Expenditure Report. Domestic Revenue is at budget expectations. Industrial Revenue is trending better than budgeted expectations due to a temporary increase in revenue from one industrial user. Facility and Tap Fees are above budgeted expectations due to receiving approximately \$1.2 million from two developers. Interest and miscellaneous income are above budgeted expectations due to actual short-term interest rates being better than anticipated for the fiscal year. O&M expenditures are at 51% of budget. They include encumbered amounts. These amounts will be spent in future periods. encumbrances as of the end of the second quarter were approximately \$700,000.00. Bond principal and interest expenditures are reflected at 50%. This will aid the user to properly assess debt service commitments on a budgetary perspective. Actual amount spent as of the end of the second quarter is approximately 21.54%. This is due to the timing of the District's debt service payments. Amounts budgeted for capital equipment and capital projects are rarely expended proportionately throughout the year. Due to the timing of capital projects, these amounts are considered reasonable.

#### e. Cash Commitment/Investment Report Month ended December 2018:

Mr. Powell reported that Page 46 presents the makeup of the District's Investment Portfolio. There has been no significant change in the makeup of the portfolio from the prior month. Page 47 presents the MSD investment managers report for the month of December. The weighted average maturity of the investment portfolio is 196 days. The yield to maturity is 2.42% and is exceeding our bench marks of the NCCMT portfolio. Page 50 presents the MSD Variable Debt Service report. The 2008A Series is performing at budgeted expectations. As of the end of January this issue has saved the District rate payers approximately \$5.8 million in debt service since April of 2008.

With no further discussion, Mr. VeHaun called for a motion to approve the Consolidated Motion Agenda. Mr. Pelly moved. Mr. Whitesides seconded the motion. Roll call vote was as follows: 12 Ayes; 0 Nays.
