# BOARD OF THE METROPOLITAN SEWERAGE DISTRICT June 10, 2020

#### 1. Call to Order and Roll Call:

The regular monthly meeting of the Metropolitan Sewerage District Board was held on Wednesday, June 10, 2020 at 2 PM. Due to the Covid-19 virus, Board Members and some staff attended the meeting remotely, using the "Go To Meeting" software application. Attendance was available via web access or telephone. Members of the public were able to access the meeting as well. Chairman Vehaun presided with the following members present via internet or telephone access: Bryson, Kelly, Manheimer, Pennington, Pressley, Valois, Watts, Whitesides and Wisler. Ashley and Pelly were absent.

Others present via internet or telephone access were William Clarke, General Counsel; Marcus Jones with Cane Creek Water & Sewer District; Tom Hartye, Ed Bradford, Scott Powell, Matthew Walter, Julie Willingham and Pam Nolan, MSD.

#### 2. Inquiry as to Conflict of Interest:

Mr. VeHaun asked if there were any conflicts of interest with the agenda items. No conflicts were reported.

#### 3. Approval of Minutes of the May 20, 2020 Board Meeting:

Mr. VeHaun asked if there were any changes to the Minutes of the May 20, 2020 Board Meeting. Mr. Watts moved for approval of the minutes as presented. Mr. Kelly seconded the motion. Voice vote in favor of the motion was unanimous.

- 4. Discussion and Adjustment of Agenda: None.
- 5. Introduction of Guests: Mr. VeHaun welcomed Marcus Jones.
- 6. Informal Discussion and Public Comment: There was no public comment.

#### 7. Report of General Manager:

Mr. Hartye reported that the MSD and Cane Creek Consolidation will officially begin July 1, 2020. The Consolidation Agreement and a proposed rental agreement for an office in the Henderson County Permitting building for an MSD employee are on this meeting's agenda.

Mr. Hartye reported that the Final Budget and Public Hearing will be held at this Board Meeting. There are no changes to the Preliminary Budget that was brought to the May Board Meeting.

Mr. Hartye reported that the next regular Board Meeting will be held on July 15, 2020 at 2 pm. The next Right of Way Committee meeting will be held on July 22, 2020 at 9 am.

#### 8. Consolidated Motion Agenda:

#### a. Consideration of Lease Agreement – MSD Office Space in Henderson County Permitting Building:

#### Minutes June 10, 2020 Page Two

Mr. Hartye reported that attached is a Lease Agreement. This office will be located in the one-stop permitting building at 100 North King Street. Customers will be able to make payments and process applications at this location. This office will be open part-time, each morning from Monday through Friday. The office space is approximately 90 square feet and will cost \$900 per year. Mr. Hartye stated that he and Staff believe this is a good value. Staff recommends approval of the Lease Agreement with Henderson County.

### b. Consideration of Developer Constructed Sewer Systems: Central Avenue Sewer Extension, Sweet Birch Lane Phases 1 & 2; White Oak Circle Phase 1:

Mr. Hartye reported that the Central Avenue project is located in the Town of Weaverville and consisted of extending approximately 270 linear feet of 8-inch public gravity sewer to serve the 7 residential units for this project.

Mr. Hartye reported that the Sweet Birch Lane Phases 1 & 2 project is located in the Town of Black Mountain and included extending approximately 772 linear feet of 8-inch public gravity sewer to serve 60 townhouses.

Mr. Hartye reported that the White Oak Circle Phase 1 project is located in the Town of Black Mountain and included extending approximately 226 linear feet of 8-inch public gravity sewer to serve the 2 residential units for this phase.

Staff recommends acceptance of the aforementioned developer constructed sewer systems. All MSD requirements have been met.

# c. Consideration of Bids – Calcium Nitrate Solution for Odor & Hydrogen Sulfide Control Contract FY 21:

Mr. Hartye reported that MSD has been using a calcium nitrate solution for the last few years to control hydrogen sulfide formation in the South French Broad Interceptor. It is effective in combating the formation of hydrogen sulfide and preventing the degradation of the pipes themselves. A virtual bid opening was held on May 18, 2020. Aulick was the lowest bidder at 2.18/gallon and agrees to hold their price firm for the total year irrespective of market changes. MSD Staff has checked references and feels comfortable with both the quality of the chemicals and the customer service that will be supplied by Aulick. Staff recommends that the Board award the contract for the supply of calcium nitrate solution to Aulick at a unit price of \$2.18/gallon.

#### d. Report on MSD Paving Agreement with City of Asheville:

Mr. Hartye reported that this is an annual agreement with the City of Asheville and is for small road patches of 300 SF or less within City Limits. For FY 20-21, the District's contribution for this agreement is \$374,220.91. This amount is based on usage throughout the past three years with a yearly patching area of about 14,000 SF. The System Services construction budget for FY 20-21 includes appropriate funding for this item. Minutes June 10, 2020 Page Three

#### e. Cash Commitment Investment Report – Month ended April 2020:

Mr. Powell reported that Page 24 presents the makeup of the District's Investment Portfolio. The only change was to divest from AAA NC VRDN and reinvest in the NCCMT Government Portfolio. Page 25 presents the MSD Investment Manager's report as of the month of April. The weighted average maturity of the investment portfolio is 47 days and the yield to maturity is .87%. Page 26 presents the analysis of the District's cash receipts. Monthly and YTD Domestic and Industrial Revenue are considered reasonable based on timing of cash receipts in their respective fiscal periods. YTD Facility and Tap Fees are at historical trends. Page 27 presents the analysis of the District's Expenditures. Monthly and YTD O&M expenditures are considered reasonable based on historical trends. Due to the nature of the variable rate bond market, Monthly and YTD expenditures can vary from year to year. Based on current variable interest rates, debt service expenditures are considered reasonable. Due to nature and timing of capital projects, YTD expenditures can vary from year to year. Based on the current outstanding capital projects, YTD capital project expenditures are considered reasonable. Page 28 presents the MSD Variable Debt Service Report. The 2008A Series refunding bonds are performing at budgeted expectations. As of the end of May, the issue has saved the District rate payers \$6.3 million in debt service since April 2008.

With no further discussion, Mr. VeHaun called for a motion to approve the Consolidated Motion Agenda. Mr. Kelly moved, Ms. Bryson seconded the motion. Roll call vote was as follows: 10 ayes; 0 Nays.

#### 9. Consideration of Consolidation Agreement between MSD and Cane Creek Water and Sewer District:

Mr. Hartye reported that the process as prescribed by MSD's enabling legislation and as amended by House Bill 758 has been successfully completed. The EMC approved the Consolidation at their May 7, 2020 meeting. Attached is a Consolidation Agreement drafted by Billy Clarke with input from both MSD and Henderson County staff for consideration by this Board and the Henderson County Commissioners at their June 17, 2020 Meeting. MSD staff has been gearing up over the last 9 months to facilitate the incorporation of the CCWSD system operation into our work plans. This includes Operation and Maintenance, Capital Construction, Planning and Development and Billing. While no agreement can cover everything, we believe that this agreement covers the critical elements to guide a smooth transition. Staff recommends that the MSD Board approve the attached Consolidation Agreement between MSD and CCWSD. Mr. Hartye asked Mr. Clarke if he would like to add anything. Mr. Clarke added that they have worked a lot with Marcus Jones and Russ Burrell and thanked them for all of their help. He further stated that he felt like this was a good agreement. With no further discussion, Mr. VeHaun called for a motion to approve the Consolidation Agreement between MSD and Cane Creek Water and Sewer District. Mr. Watts moved, Mr. Pressley seconded the motion. Roll call vote was as follows: 10 ayes; 0 Nays.

# 10. Public Hearing: Consideration of Resolution Adopting Final Budget for FY 20-21 and Schedule of Sewer Rates and Fees:

Mr. Powell reported that the numbers included in the Proposed Preliminary Budget are the same as in the Proposed Final Budget. The Proposed Final Budget for FY20-21 is \$56,600,826.00 and incorporates the following:

- No Fee Increases
- No change in Sewer System Development Fees and Sewer Connection Fees in accordance with Staff's recommendation
- .5% rate of return on investments
- 0% increase in Salaries
- 6.5% increase in funding for the self-insurance plan which has an impact of \$151,000.00
- 13.4% increase in the State required funding for the NC Retirement Plan which has an impact of \$109,000.00
- 5.6% increase in Materials supplies and service to address specific regulatory and operational needs which has an impact of \$378,000.00.

Mr. Powell reported that the final item included is the Budget Resolution and Schedule of Rates and Fees. He then asked if there were any questions. There were none.

Mr. VeHaun called for public comment on the proposed Budget, Resolution and Schedule of Rates and Fees for FY 20-21. There were none.

With no discussion, Mr. VeHaun called for a motion to approve the Resolution adopting the Final Budget for FY 2020-2021 and Schedule of Sewer Rates and Fees. Ms. Wisler moved. Mr. Whitesides seconded the motion. Roll call vote was as follows: 10 Ayes; 0 Nays.

#### 12. New Business:

Mr. Hartye reported that due to this meeting being held virtually and now that the Board has voted on the Budget, MSD will receive public comments for 24 hours. If there are any comments, those will be shared with this Board.

#### 1. Call to Order and Roll Call:

The regular monthly meeting of the Metropolitan Sewerage District Board was held on Wednesday, May 20, 2020 at 2 PM. Due to the Covid-19 virus, Board Members and some staff attended the meeting remotely, using the "Go To Meeting" software application. Attendance was available via web access or telephone. Members of the public were able to access the meeting as well. Chairman Vehaun presided with the following members present via internet or telephone access: Ashley, Bryson, Kelly, Manheimer, Pennington, Pressley, Valois, Watts, Whitesides and Wisler. Pelly was absent.

Others present via internet or telephone access were William Clarke, General Counsel; Tom Hartye, Ed Bradford, Scott Powell, Roger Edwards, Mike Stamey, Angel Banks and Pam Nolan, MSD.

#### 2. Inquiry as to Conflict of Interest:

Mr. VeHaun asked if there were any conflicts of interest with the agenda items. No conflicts were reported.

### 3. Approval of Minutes of the April 15, 2020 Board Meeting:

Mr. VeHaun asked if there were any changes to the Minutes of the April 15, 2020 Board Meeting. Mr. Pressley moved for approval of the minutes as presented. Mr. Kelly seconded the motion. Voice vote in favor of the motion was unanimous.

## 4. Discussion and Adjustment of Agenda: None.

### 5. Introduction of Guests: None.

## 6. Informal Discussion and Public Comment:

There was no public comment.

#### 7. Report of General Manager:

Mr. Hartye reported that, regarding Operational Adjustments during COVID-19, MSD is back to full force with rotations and several adjustments to work flow in order to keep folks safe. The Administration building is not yet open to the public. The plan is to do so when the State Order reaches Phase 3.

Mr. Hartye reported that The NC Environmental Management Commission (EMC) approved the Cane Creek Consolidation at it's May 7, 2020 full Board Meeting. He reported that they were very complimentary and excited. This is one of the few regionalization requests that they get. Staff and Counsel are currently working on a consolidation agreement with Henderson County to bring before this Board at the June 10<sup>th</sup> regular Board Meeting.

Mr. Hartye reported that Jim Parker at 387 Pearson Drive called in to express his appreciation to Wayne Rice for his assistance.

Minutes May 20, 2020 Page Two

Mr. Hartye reported that attached is a letter regarding the NC Retirement Plan required as a part of legislation enacted in 2015. This lists MSD personnel who have recently been promoted and are already vested in the NC Retirement Plan. This letter lets MSD know that if this employee were to retire today, MSD may owe some retirement monies to the system. The employee listed is not planning to retire for at least 4 years.

Mr. Hartye reported that the May Right of Way Committee Meeting has been cancelled. The next regular Right of Way Committee meeting will be held on June 24, 2020 at 9 am. The next regular Board Meeting will be held on June 10, 2020 at 2 pm, which is a week early due to budget requirements.

#### 8. **Report of Committees:**

### a. Right of Way Committee – April 22, 2020

Mr. Kelly reported that the Right of Way Committee met on April 22, 2020 and made routine recommendations which are included in this Board package.

### b. CIP Committee – April 23, 2020

Mr. Watts reported that the CIP Committee met on April 23, 2020 and had a very good meeting. He expressed his appreciation to Mr. Bradford for the presentation. The CIP Committee recommends approval of Staff's recommendation of Endorsement of the CIP Budget for FY 20-21.

#### c. Personnel Committee – April 28, 2020

Mrs. Bryson reported that the Personnel Committee met on April 28, 2020. She reported that Mrs. Thomas gave statistics on MSD employees including average age and years of service. Mrs. Thomas also presented information of projected health costs for MSD. There were several questions, which Mrs. Thomas answered. She then presented Staff's recommendation of a 0% wage adjustment at this time and a 6.5% increase for the Self-Insured Medical Plan. Personnel Committee recommends approval of Staff's recommendation.

## d. Finance Committee – May 1, 2020

Mr. Kelly reported that the Finance Committee met on May 1, 2020 and recommends acceptance of Staff's recommendation to approve the FY20-21 Budget in the amount of \$56.6 Million and for the Schedule of Sewer Rates and Fees for FY20-21 to remain as they currently exist.

#### 9. Consolidated Motion Agenda:

## a. Consideration of Condemnation – Chestnut Lodge Road GSR, Hall:

Mr. Hartye reported that MSD's Project Engineer accommodated owner's request with alignment revisions. Mr. Hall agreed with these revisions but the sticking point at this time is compensation. Mr. Clarke has contacted owner's

attorney, Ron Sneed, requesting the land sales used as basis for their counteroffer. There have been 12 contacts. Staff and Committee recommend authority to obtain appraisal and proceed with condemnation if necessary.

# b. Consideration of Condemnation – Chestnut Lodge Road GSR, Fletcher:

Mr. Hartye reported that owner is elderly and requests that all communication go through her son-in-law who lives in Florida. The son-in-law disputes the boundary shown on the easement plat provided by MSD's surveyor. Neither the son-in-law or the owner have responded to the standard compensation offer and Staff has made seven contacts. Staff and Right of Way Committee recommend authority to obtain appraisal and proceed with condemnation, if necessary.

## c. Consideration of Condemnation – Chestnut Lodge Road GSR, M&M Mountain Properties, Morgan Ortiz:

Mr. Hartye reported that this proposed alignment was shifted into the asphalt drive to get the sewerline out from underneath the garage and mobile home. Owner has not responded to either the provisions or standard compensation despite numerous phone calls, e-mails and a certified letter. There have been a total of 11 contacts with this owner. Staff and Right of Way Committee recommend authority to obtain appraisal and proceed with condemnation, if necessary.

# d. Consideration of Developer Constructed Sewer System: Fountain Park Phase 1:

Mr. Hartye reported that the Fountain Park Phase 1 project is located off of Pond Road in Buncombe County and included extending approximately 3,412 linear feet of 8-inch public gravity sewer to serve the 120 residential units for this phase.

Staff recommends acceptance of the aforementioned developer constructed sewer systems. All MSD requirements have been met.

# e. Extension of the MSD FY20 Non-City of Asheville Road ROW Paving Contract:

Mr. Hartye reported that for the last 2 years MSD has contracted with French Broad Paving. Due to the COVID pandemic, Staff has decided to extend the current contract to September 1, 2020. This will allow time to prepare for prebid conferences, public meetings, etc. which require public contact.

# f. Consideration of Declaration of Intent to Adopt Revised MSD Sewer Use Ordinance:

Mr. Hartye reported that this Declaration of Intent was brought to the February 2020 Board Meeting. It was then sent out to Member Agencies for comment. There were no specific comments from Member Agencies. There were 2 small changes from the Division of Water Resources which have been incorporated.

Staff recommends adoption of the Sewer Use Ordinance as written with comments accepted from Division of Water Resources.

## g. Cash Commitment Investment Report – Month ended March 2020:

Mr. Powell reported that Page 84 presents the makeup of the District's Investment Portfolio. Due to a one month freeze in the short-term market, the District invested 26% in AAA municipal VRDN to offset the cash outflow associated with the 2008 interest rate swap. Page 85 presents the MSD Investment Manager's report as of the month of March. The weighted average maturity of the investment portfolio is 46 days and the yield to maturity is 1.71%. Page 86 presents the analysis of the District's cash receipts. Monthly and YTD Domestic and Industrial Revenue are considered reasonable based on timing of cash receipts in their respective fiscal periods. YTD Facility and Tap Fees are above historical trends due to the timing of 7 cash receipts from developers as well as these fees being budgeted conservatively. Page 87 presents the analysis of the District's Expenditures. Monthly and YTD O&M expenditures are considered reasonable based on historical trends. Due to the nature and timing of the variable rate bond market, Monthly and YTD expenditures can vary from year to year. Based on current variable interest rates, debt service expenditures are considered reasonable. Due to nature and timing of capital projects, YTD expenditures can vary from year to year. Based on the current outstanding capital projects, YTD capital project expenditures are considered reasonable. Page 88 presents the MSD Variable Debt Service Report. The 2008A Series refunding bonds are performing at budgeted expectations. As of the end of April, the issue has saved the District rate payers \$6.3 million in debt service since April 2008.

# 10. Consideration of Proposed Resolution Adopting Preliminary Budget for FY 20-21 and Schedule of Sewer Rates and Fees:

Mr. Powell reported that Page 21 presents the proposed FY 20-21 budget of \$56,600,826. There is no change to the sewer service fees, industrial service fees, sewer system development fees and sewer connection fees in accordance with Staff's recommendation. There is a projected .5% Rate of Return on investments. There is a 0% increase in Salaries. There is a 6.5% increase in funding for the self-insurance plan which comes to \$151,000. There is a 13.4% increase in the State required funding for the NC Retirement Plan of \$109,000. Also included is a 5.6% increase in materials, supplies and service to address specific regulatory and operational needs which has an impact of \$378,000. Mr. Powell reported that Page 31 of the pdf document contains the detailed summary of items asked to be approved for this fiscal year. There were no questions or comments from the Board.

With no further discussion, Mr. VeHaun called for a motion to adopt Item 9. Consolidated Motion Agenda and Item 10. Consideration of Proposed Resolution Adopting Preliminary Budget for FY 20-21 and Schedule of Sewer Rates and Fees. Ms. Wisler moved. Mr. Pressley seconded the motion. - **BACKGROUND:** The Cane Creek Water and Sewer District (CCWSD) will merge with the Metropolitan Sewerage District of Buncombe County on July 1, 2020. In order to provide effective customer service for residents and businesses in Northern Henderson County, an MSD office space is proposed in downtown Hendersonville.

The office will be located in the one-stop permitting building located at 100 North King Street. Customers will be able to make payments and process applications at this location. The office will be staffed by a current Henderson County employee who has handled administrative tasks for CCWSD for over a decade. It will be open part-time, each morning from Monday through Friday.

The office space is 90 square feet (it is part of a larger area) and the rental rate is \$10 per square foot per year, or \$900 per year. Staff has reviewed the rate and is comfortable that it is a good value.

It is also important to note that customers can also submit applications using MSD's online permitting process. This provides an alternate method to apply for new service (from anywhere).

Please refer to the attached documentation for further details.

- **FISCAL IMPACT:** The annual rental rate is \$10 per square foot per year (\$900 per year). Funding has been incorporated into the District's FY20-21 budget.
- **STAFF RECOMMENDATION:** Staff recommends approval of the Lease Agreement with Henderson County.

#### STATE OF NORTH CAROLINA COUNTY OF HENDERSON

This Interlocal Agreement, pursuant to Article 20 of Chapter 160A, is made by and between the County of Henderson, a body corporate and politic of the State of North Carolina ("the County") and the Metropolitan Sewerage District of Buncombe County, North Carolina, a body corporate and politic of the State of North Carolina ("the District").

#### Facts Leading to Agreement:

- A. The County and the District have discussed leasing a portion of the County's King Street Office Building to the District, so that the District will have a physical presence within the County permitting offices. This presence is desired due to the merger of the Cane Creek Water and Sewer District with the District.
- B. It is the intent of the parties that this presence by the District will:
  - (1) Facilitate a single location for the residents within the Henderson County portion of the District to obtain all land development information and permits.
  - (2) Provide a better opportunity for District and County staff to communicate regarding permitting and inspection issues associated with planned and active projects.
  - (3) Provide citizens and staff an opportunity to resolve issues that may arise in the development process in a central location accessible to both District and County residents.

#### Statement of Agreement

The parties agree as follows:

- (1) The County hereby leases to the District office space in the County's office building at 100 North King Street, or such other premises as the parties may later agree (such office space hereafter "the leased premises"), suitable for a satellite location of the Planning and Development Department of the District.
- (2) The leased premises consist of 90 square feet, and is part of a larger area. The larger area space may contain County files and may periodically be a shared space by other County staff.
- (3) The initial term of this lease shall be five (5) years, beginning 1 July 2020. However, unless either party shall give notice of the intention to terminate this provision at least six (6) months prior to the end of the term (that is, not later than 31 December 2024), then the lease shall be extended for another term of five (5) years. The District or the County may terminate this lease without penalty, prior to the end of the initial term or any subsequent term on 60 days written notice to the other party.
- (4) The District will pay to the County as rent the sum of Ten Dollars (\$10.00) per square foot of the leased premises per year, beginning 1 July 2020.

**Background:** MSD has been using a calcium nitrate based solution for the last few years to control hydrogen sulfide formation in the South French Broad Interceptor. Hydrogen sulfide is formed in wastewater after bacteria has used most of the available oxygen. It has a predominate rotten egg odor and is easily broken out of the wastewater. When in the air space in a sewer line, it also converts to sulfuric acid which erodes the inside of sewer pipes. Calcium nitrate has proven to be effective in combating the formation of hydrogen sulfide and preventing the degradation of the collection system. Current contracted cost for calcium nitrate is \$1.99/gallon, with an estimated expenditure for FY20 – based on 70,000 gallons usage – of \$139,300.00.

**Discussion**: Pursuant to North Carolina Purchasing Statutes and MSD Procedures, on April 29, 2020, bids were emailed to vendors and an advertisement was placed on the MSD web site. Three bids were received. With approval of MSD Counsel, a Virtual bid opening - using the medium "GoToMeeting" - was held May 18, 2020. Aulick was the lowest bidder at \$2.18/gallon and agrees to hold their price firm for the total year contract irrespective of market changes. Aulick is a new supplier of calcium nitrate solution to MSD. MSD staff has checked references and feels comfortable with both the quality of the chemicals and the customer service that will be supplied by Aulick.

**Fiscal Impact**: This is a Unit Price Contract, without minimum or maximum quantities. Based on an estimated use of 70,000 gallons at \$2.18/gallon, the annual expenditure for calcium nitrate solution is anticipated to be \$152,600.00 and is within levels budgeted by the WRF.

**Staff Recommendation**: Staff recommends that the Board award the contract for the supply of calcium nitrate solution to Aulick at a unit price of \$2.18/gallon.

This restoration work is the result of District in-house<br/>maintenance and rehabilitation activities on the sewer system.Prior to FY 12, all pavement and sidewalk restoration after MSD work was

performed by contractors. This process worked well, with the exception of administrative & permitting issues concerning City of Asheville streets. With these concerns in mind, the City and the District entered an agreement on July 1, 2011 wherein the District would pay the City an annual contribution to a Paving Enterprise Fund and all pavement restoration would be performed by the City's in-house paving crews. This agreement was executed between MSD and the City for both the FY 12 and FY 13 years.

During these two contract years, the City crews provided excellent service relating to asphalt and concrete patching for the subject roadways, especially for the cuts of approximately 300 SF or less. Asphalt restoration for projects larger than 300 SF however was found to be very costly and difficult to complete by City crews in a timely manner due to workload.

As such, MSD and the City worked together in the spring of 2013 to facilitate an annually renewing agreement which provided greater efficiency and economic feasibility for both sides. The details of the agreement include City crews performing asphalt and concrete patching restoration work for MSD within City Right of Ways for areas of approximately 300 SF or less. In areas greater than 300 SF and for asphalt overlays, MSD contracts out the pavement restoration. For this agreement the City provides monthly reports to MSD and MSD makes monthly payments for completed restoration work. Additionally, MSD is not required to pay permit fees.

This annually renewing agreement was approved by the MSD Board at the June 12, 2013 meeting. For FY 20-21, the District's monetary contribution for this agreement is \$374,220.91. This amount is based upon usage throughout the past three years with a yearly patching area of approximately 14,000 SF.

The District must still contract out for paving overlays and patches in the City which exceed approximately 300 SF and for all paving work for the remaining areas outside the Asheville City Limits / Right of Ways.

**FISCAL IMPACT:** The System Services CIP Construction budget for FY 20-21 includes appropriate funding for this item.

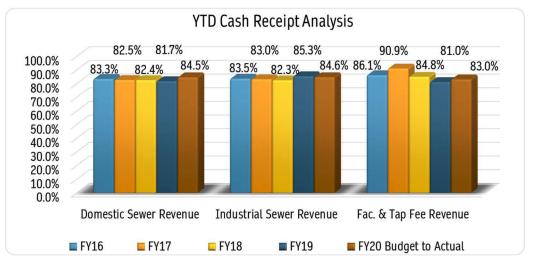
Analysis of Cash Receipts

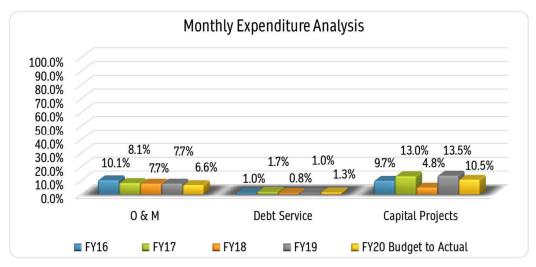

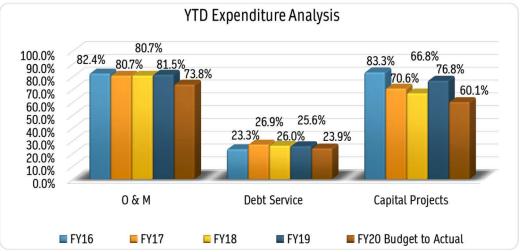
Analysis of Expenditures

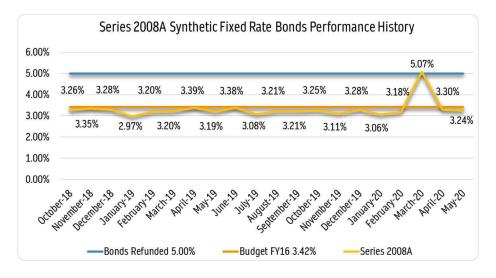

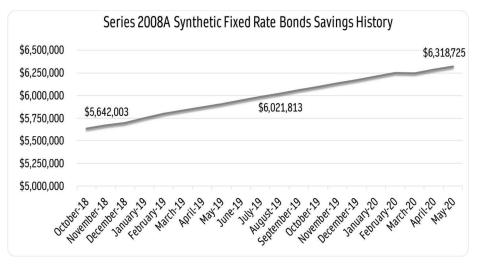

- Subject: Consideration of Consolidation Agreement between MSD and Cane Creek Water and Sewer District
- **Background:** House Bill 758 (SL 2019-127) amended MSD's enabling legislation to allow for Henderson County to consolidate with MSD under a revised process whereby, once requested, MSD will prepare information to be brought to the Environmental Management Commission (EMC). After the required public hearing/input, if the consolidation is approved by the EMC, Henderson County shall appoint two representatives from the Cane Creek Water and Sewer District (CCWSD) territory to the MSD Board.

At their August 5, 2019 meeting the Henderson County Commissioners passed a resolution requesting inclusion into the District. MSD gathered the required information and conducted an impact study of the requested consolidation. The MSD Board approved the information to be submitted to the EMC at the October 16, 2019 Regular Board Meeting. At their January 9, 2020 meeting the EMC voted to move ahead with the required process. The required public hearings were held on March 12<sup>th</sup> and April 27<sup>th</sup>. The EMC approved the Consolidation at their May 7, 2020 meeting.

MSD and the City of Hendersonville have developed a billing services agreement which was approved by both the Hendersonville City Council and the MSD Board. On this month's agenda is a rental agreement with Henderson County for office space for a Planning and Development employee in their centralized facility.

Attached is a Consolidation Agreement drafted by Billy Clarke with input from both MSD and Henderson County staff for consideration by the MSD Board and the Henderson County Commissioners.

MSD staff has been gearing up over the last 9 months to facilitate the incorporation of the CCSWD system operation into our work plans. This includes Operation and Maintenance, Capital Construction, Planning and Development and Billing. While no agreement can cover everything, we believe that this agreement covers the critical elements to guide a smooth transition.

**Recommendation**: Staff recommends that the MSD Board approve the attached Consolidation Agreement between MSD and CCWSD.

This CONSOLIDATION AGREEMENT, made this \_\_\_\_\_ day of June, 2020, by and between the **METROPOLITAN SEWERAGE DISTRICT OF BUNCOMBE COUNTY**, a North Carolina public body and body politic and corporate created and established under the provisions of the North Carolina Metropolitan Sewerage Districts Act, Chapter 153, Article 25, Sections 153-295 to 153-324, inclusive (succeeded by Chapter 162A-64-81, inclusive) of the North Carolina General Statutes, with its principal office and place of business at 2028 Riverside Drive, Woodfin, N.C. 28814 (hereinafter "MSD" or "District") and the CANE CREEK WATER AND SEWER DISTRICT of Henderson County, a body corporate and politic with its principal office and place of business at 100 North King Street, Hendersonville, N.C. 28792 (hereinafter "CCWSD" or "CANE CREEK").

#### <u>WITNESSETH</u>

WHEREAS, MSD was created and established by the North Carolina State Stream Sanitation Committee by resolution adopted on January 19, 1962, and MSD is currently comprised of the following political subdivisions;

City of Asheville Town of Biltmore Forest Town of Weaverville Town of Black Mountain Town of Woodfin Woodfin Sanitary Water and Sewer District Avery Creek Sanitary District **Busbee Sanitary District Crescent Hill Sanitary District Skyland Sanitary District** Fairview Sanitary District East Biltmore Sanitary District Caney Valley Sanitary District Swannanoa Water and Sewer District Beaverdam Water and Sewer District Venable Sanitary District Enka-Candler Water and Sewer District

WHEREAS, MSD operates and maintains a system of interceptor and collector sewer lines and a wastewater treatment facility which system of interceptor and collector sewer lines and wastewater treatment facility is referred to herein as the "District Sewerage System;" and

WHEREAS, CCWSD was established on February 26, 1981 pursuant to the provisions of Article 6 of Chapter 162A of the North Carolina General Statutes; and

WHEREAS, CCWSD owns, operates and maintains a system of interceptor and collector sewers serving north Henderson County; and

WHEREAS, MSD currently accepts and treats wastewater collected by CCWSD in the District Sewerage System pursuant to an agreement between MSD and CCWSD entered into in March 1988 and amended in March 1989 and October 1990 (the "Existing Agreement") ; and

WHEREAS, in 2019, the North Carolina General Assembly enacted House Bill 768 which created a new section, *G.S. 162A-68.5*, in Article 5 of Chapter 162A of the General Statutes; and

WHEREAS, G.S. 162A-68.5 allows a metropolitan sewerage district to expand into another county if the governing body of the other county requests the extension and meets the criteria in G.S. 162A-68.5; and

WHEREAS, The Board of Commissioners of Henderson County, acting in its official capacity and as the governing body of CCWSD, adopted, on August 5, 2019, a Resolution requesting the inclusion of CCWSD into MSD; and

WHEREAS, the criteria in G.S. 162A-68.5 are met; and

WHEREAS, upon receipt of the August 5, 2019 Resolution, MSD prepared and sent the information described in *G.S. 162A-68.5 (b)* to the North Carolina Environmental Management Commission ("EMC") on October 16, 2019; and

WHEREAS, the Water Quality Committee of the EMC considered the request by CCWSD to be included in MSD at its meeting on November 13, 2019, and recommended that the full EMC proceed to public hearing on the request; and

**WHEREAS,** the full EMC, at its meeting on January 9, 2020, approved proceeding to a public hearing in Henderson County on the request; and

WHEREAS, the Henderson County Board of Commissioners and the EMC held a public hearing on CCWSD's request to be included into MSD on March 12, 2020 at West Henderson High School in Henderson County and a telephonic public hearing on April 27, 2020 with Lon T. Snider, Regional Supervisor, Winston-Salem Regional Office, of the North Carolina Division of Water Resources acting as hearing officer at both hearings; and

WHEREAS, the hearing officer prepared and submitted a report to the EMC based on the documentation submitted by CCWSD and MSD and the public hearings; and

WHEREAS, the EMC considered the request for inclusion at its May 7, 2020 meeting, and the EMC determined that the criteria of G.S. 162A-68.5 were met, and the inclusion of the CCWSD of Henderson County within the MSD would not adversely affect customer service in the District and would preserve and promote the public health and welfare of the District; and

WHEREAS, the EMC adopted, at its May 7, 2020 meeting, a resolution expanding the boundaries of the Metropolitan Sewerage District of Buncombe County to include all of the territory of the CCWSD of Henderson County, effective July 1, 2020; and

WHEREAS, Under Article 5 of Chapter 162A of the General Statutes, MSD is authorized and empowered among other things:

- (a) to acquire, construct, reconstruct, improve, extend, enlarge, equip, repair, maintain and operate a sewerage system;
- (b) to fix and revise rates, fees and charges for the use of or for the services and facilities provided by the District Sewerage System;
- (c) to make and enter into contracts or agreements with the governing body of any political subdivision upon such terms and conditions and for such periods as any such governing body and the District Board of the District may determine with respect to:
  - (i) the collection, treatment and disposal of sewage; and

(ii) the collection by such political subdivision or by the District of rents, rates, fees or charges for the services and facilities provide to or for such political subdivision and for the enforcement of collection of such rents, rates, fees or charges;

- (d) to regulate by permit the discharge of waste into the District Sewerage System by any industrial or commercial establishment; and
- (e) to acquire by gift, purchase or the exercise of the right of eminent domain, any improved or unimproved lands or rights in land, and to acquire such personal property as it may deem necessary in connection with the acquisition, construction, reconstruction, improvement, extension, enlargement, repair, equipment, maintenance or operation of any sewerage system; and

WHEREAS, CCWSD is a body corporate and politic as defined in *G.S. 162A-88* and has the authority to buy, sell and dispose of real and personal property; and

WHEREAS, pursuant to *G.S. 162A-85.5*, CCWSD has the authority to do all acts and things necessary to carry out the powers granted to it under Article 6 of Chapter 162A; and

WHEREAS, MSD and CCWSD enter into this Agreement to 1) terminate the Existing Agreement, 2) transfer all assets and liabilities of CCWSD to MSD; and 3) clarify and define their respective responsibilities as to the District Sewerage System; and

WHEREAS, MSD is bound by the terms of its Amended and Restated Bond Order adopted by the District Board on April 21, 1999, governing outstanding bonds of MSD, to make improvements to the District Sewerage System only on such land which is owned or can be acquired by MSD in fee simple or over or under which the District shall have acquired or can acquire proper easements or title or rights sufficient for the needs and purposes of the improvements to the District Sewerage System; and

WHEREAS, the MSD Board has determined that the inclusion of the CCWSD Sewerage System as a part of MSD, and the related responsibility to operate, maintain, repair, and replace, if necessary, the CCWSD Sewerage System will preserve and promote the public health and welfare within the District and not adversely affect service to users of the District Sewerage System; and

WHEREAS, the MSD Board has determined that the CCCWSD Sewerage System is not subject to any lien or other encumbrance which is materially adverse; and

WHEREAS, the MSD Board has determined that adequate funding for the acquisition, operation, maintenance, repair, and replacement, if necessary of the CCWSD Sewerage System is or will be available from available funds of the District, from rates, fees and charges

established by the District, from grants or other funds provided by the United States of America, the State of North Carolina or any other source, from the issuance of revenue bonds of the District or from any combination of such sources, as the MSD Board deems appropriate; and

WHEREAS, CCWSD desires to transfer ownership of the CCWSD Sewerage System, as defined herein, to MSD, and MSD is willing to accept ownership of the CCWSD Sewerage System according to the terms and conditions set forth in this agreement;

**NOW, THEREFORE,** in consideration of the mutual covenants, terms, conditions and obligations herein undertaken, it is agreed as follows:

- CCWSD hereby agrees to transfer to MSD all of the CCWSD Sewerage System more particularly described in paragraph 2 herein. The transfer shall occur on July 1, 2020. The transfer shall be in accordance with the terms and conditions set forth in this agreement and relevant provisions of *G.S. 162A-68.5*. The transfer of real property owned by CCWWDS shall be effected by a document in generally the same form as the "DEED" attached to this agreement as Exhibit A. CCWSD and MSD agree to execute all necessary documents to complete the transfer of property from CCWSD to MSD.
- For purposes of this Agreement, the "CCWSD Sewerage System" shall mean all of CCWSD's interest in the following properties:
  - (a) All of the existing collector and interceptor sewers, pump stations and related appurtenances shown on the map of the Cane Creek Water and Sewer District attached hereto as Exhibit B.

- (b) All of the existing collector and interceptor sewers shown on the CCWSD GIS mapping system.
- (c) All easements and rights of way for sewer lines used or acquired in connection with the CCWSD Sewerage System. The easements and rights of way intended to be conveyed shall include easements which may have been acquired by long use or maintenance of sewer lines and easements.
- (d) All sewer lines, easements, or rights of way which appear on any plat recorded in the Office of the Register of Deeds for Henderson County which sewer lines have been or are being used as part of the CCWSD Sewerage System.
- (e) All engineering records, plans, specifications, maps and reports, warranties, accounting records, appropriate correspondence and other records relating to the CCWSD Sewerage System, including records in digital or electronic format.
- (f) All tangible personal property as set forth on Exhibit C attached hereto and incorporated herein by reference.
- (g) All cash on Hand.
- 3. CCWSD shall be responsible for obligations relating to the operation, maintenance, repair and replacement, if necessary, of the CCWSD Sewerage System arising prior to July 1, 2020. MSD shall be responsible for obligations relating to the operation, maintenance, repair and replacement, if necessary of the CCWSD Sewerage System, arising on or after July 1, 2020.

- 4. On and after July 1, 2020, the CCWSD Sewerage System will be part of the District Sewerage System and MSD will be responsible for the operation, maintenance, repair, and replacement, if necessary, of the District Sewerage System.
- 5. On and after July 1, 2020, MSD will be responsible for billing and collecting rates, fees and charges from users of the CCWSD Sewerage System. MSD has contracted with the entities providing water to the users, the City of Asheville and the City of Hendersonville, to bill and collect rates, fees and charges. MSD will bill directly those customers who do not purchase water from the City of Hendersonville or the City of Asheville. MSD reserves the right to bill and collect rates, fees and charges and charges of the District Sewerage System.
- The following general conditions shall govern MSD's responsibilities with respect to the operation, maintenance, repair and replacement, if necessary, of the District Sewerage System.
  - (a) Adequate funding for the operation, maintenance, repair and replacement, if necessary, shall be available from available funds of the District, from rates, fees or charges established by the District, from revenue bonds issued by MSD, from grant funds from the United States or the State of North Carolina, or any other source. MSD shall have final discretion as to which source or sources of funding will be utilized, subject to the provisions of its Bond Order and to applicable law.
  - (b) MSD shall determine the rates, fees and charges to be charged to the users of the District Sewerage System in its sole and absolute discretion. The rates, fees and

charges may vary from user to user based on the composition and quantity of sewage discharged into the District Sewerage System; however, such rates, fees and charges shall not exceed the rates, fees or charges for comparable service elsewhere within the geographical limits of the District

- (c) MSD shall have final discretion in determining the need, priority, timing and location of any operation, maintenance, repair or replacement, if necessary, of the District Sewerage System.
- Pursuant to North Carolina General Statute 162A 68.5(f), upon its inclusion within MSD, CCWSD shall be subject to all debts of the District.
- 8. MSD and CCWSD acknowledge and agree that CCWSD entered into a contract with Buchanan & Sons, Inc. to construct the Mud Creek Interceptor Sewer Project (the "Mud Creek Project") in October, 2018, a project with an approximate cost of \$3,056.970. MSD and CCWSD further acknowledge and agree that the Mud Creek Project is expected to be completed on or before December 31, 2020. CCWSD agrees that it will pay all costs arising out of or related to the work on the Mud Creek Project performed prior to July 1, 2020. On or before July 1, 2020, CCWSD will assign the contract with Buchanan & Sons to MSD. MSD will be responsible for completing the contract for the Mud Creek Project and will pay for all work performed on the Mud Creek Project after July 1, 2020.

- 9. MSD and CCWSD acknowledge and agree that CCWSD entered into an agreement with the Fletcher Academy, Inc. ("Fletcher Academy") and the Layman Foundation of North Carolina, Inc. ("Layman") wherein CCWSD, as a part of the Mud Creek Project, agreed to connect the sewer system serving the Fletcher Academy and the Layman Foundation to the CCWSD Sewerage System, and Fletcher Academy and Layman agreed to contribute \$1,025,000 to the cost of the Mud Creek Project upon its completion. In consideration of MSD assuming CCWSD's obligations to complete construction of and pay for the Mud Creek Project, CCWSD agrees that it will assign its agreement with Fletcher Academy and Layman and all rights thereunder to MSD on or before July 1, 2020.
- 10. Henderson County has incurred certain debt associated with the construction, operation and maintenance of the CCWSD Sewerage System and the Mud Creek Sewer Project. The indebtedness associated with the construction, operation, and maintenance of the CCWSD Sewerage System ("Outstanding Indebtedness") as of July 1, 2020 is:
  - (a) Installment Purchase Indebtedness Mud Creek Interceptor Project.
  - (b) Henderson County Limited Obligation Indebtedness assigned to Cane Creek Water and Sewer District.

MSD agrees to pay principal and interest on the Outstanding Indebtedness as it comes due after July 1, 2020.

11. In order to effectively serve sewer customers in CCWSD, MSD will maintain an office in the Henderson County office building located at 100 North King Street in Hendersonville, or at such other location as MSD, in its sole discretion, may determine. MSD has entered into a Lease Agreement with Henderson County, a copy of which is attached hereto as Exhibit D.

- 12. All users of the District Sewerage System shall be subject to the Sewer Use Ordinance of the Metropolitan Sewerage District of Buncombe County, North Carolina.
- 13. MSD and CCWSD acknowledge and agree that this agreement supersedes the Existing Agreement and that the Existing Agreement is terminated, effective July 1, 2020.
- 14. This agreement represents the entire agreement between MSD and CCWSD.
- 15. This agreement may be amended only by a writing signed by an authorized representative of MSD and CCWSD.
- 16. This agreement shall be governed by and under the laws of the State of North Carolina.
- 17. The effective date of this agreement is July 1, 2020.

WITNESSETH, that the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee the following:

- 1) All of the Grantor's existing collector and interceptor sewers, pump stations, and related appurtenances constituting the Cane Creek Water and Sewerage District Sewerage System (hereinafter the "CCWSD Sewerage System");
- 2) All easements and rights of way for sewer lines used or acquired in connection with the CCWSD Sewerage System. A list of the easements acquired by CCSWD is attached hereto as Exhibit A. Reference is made to the specific book and page numbers in the Henderson County Registry for a more particular description of the easements being conveyed by Grantor and acquired by Grantee.
- 3) All sewer lines, easements or rights of way which appear on any plat recorded in the Office of the Register of Deeds for Henderson County which sewer lines have been or are being used as a part of the CCWSD Sewerage System.

TO HAVE AND TO HOLD the aforesaid CCWSD Sewerage System and easements and all privileges and appurtenances thereto belonging to the Grantee in fee simple.

And the Grantor covenants with the Grantee, that Grantor has done nothing to impair such title as Grantor received, and Grantor will warrant and defend the title against the lawful claims of all persons claiming by, under or through Grantor, except for the exceptions hereinafter stated. 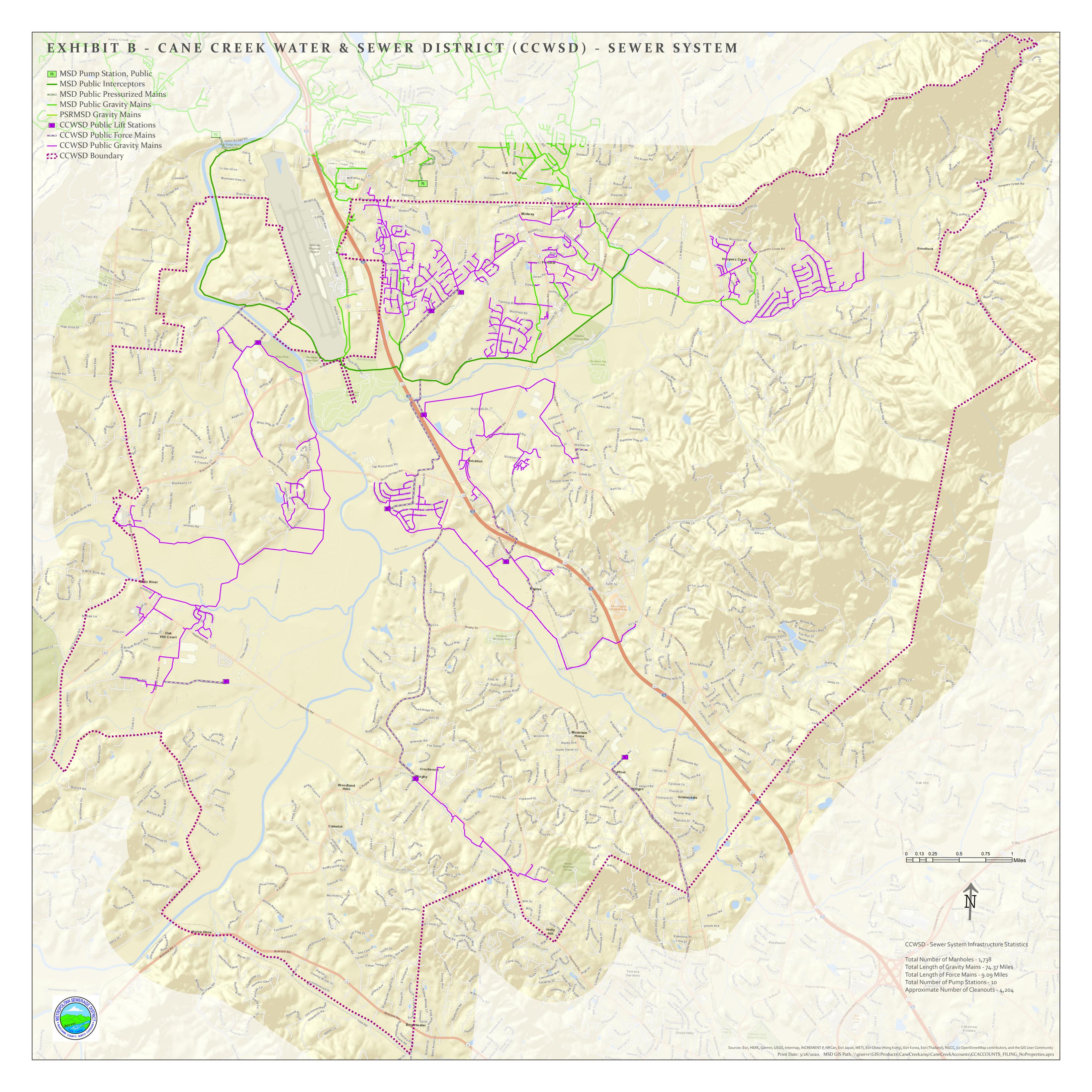

#### STATE OF NORTH CAROLINA COUNTY OF HENDERSON

#### LEASE AGREEMENT

This Interlocal Agreement, pursuant to Article 20 of Chapter 160A, is made by and between the County of Henderson, a body corporate and politic of the State of North Carolina ("the County") and the Metropolitan Sewerage District of Buncombe County, North Carolina, a body corporate and politic of the State of North Carolina ("the District").

#### Facts Leading to Agreement:

- A. The County and the District have discussed leasing a portion of the County's King Street Office Building to the District, so that the District will have a physical presence within the County permitting offices. This presence is desired due to the merger of the Cane Creek Water and Sewer District with the District.
- B. It is the intent of the parties that this presence by the District will:
  - (1) Facilitate a single location for the residents within the Henderson County portion of the District to obtain all land development information and permits.
  - (2) Provide a better opportunity for District and County staff to communicate regarding permitting and inspection issues associated with planned and active projects.
  - (3) Provide citizens and staff an opportunity to resolve issues that may arise in the development process in a central location accessible to both District and County residents.

#### Statement of Agreement

The parties agree as follows:

- (1) The County hereby leases to the District office space in the County's office building at 100 North King Street, or such other premises as the parties may later agree (such office space hereafter "the leased premises"), suitable for a satellite location of the Planning and Development Department of the District.
- (2) The leased premises consist of 90 square feet, and is part of a larger area. The larger area space may contain County files and may periodically be a shared space by other County staff.
- (3) The initial term of this lease shall be five (5) years, beginning 1 July 2020. However, unless either party shall give notice of the intention to terminate this provision at least six (6) months prior to the end of the term (that is, not later than 31 December 2024), then the lease shall be extended for another term of five (5) years. The District or the County may terminate this lease without penalty, prior to the end of the initial term or any subsequent term on 60 days written notice to the other party.
- (4) The District will pay to the County as rent the sum of Ten Dollars (\$10.00) per square foot of the leased premises per year, beginning 1 July 2020.

### Background

The District Budget process must comply with North Carolina General Statues and the MSD Revenue Bond Order. The Bond order requires that the District adopt its final budget on or before June 15 of each year. The North Carolina General Statutes required that an annual balanced budget ordinance, based upon expected revenues, along with a budget message, to be presented to the governing board no later than June 1 of each year.

The Finance Committee met in May and unanimously approved staff's recommendation to forward to the Board for approval the FY2020-2021 Preliminary Budget Document, proposed Budget Resolution, and Schedule of Rates, Fees, and Charges. On May 20th, the Board approved staff's recommendations.

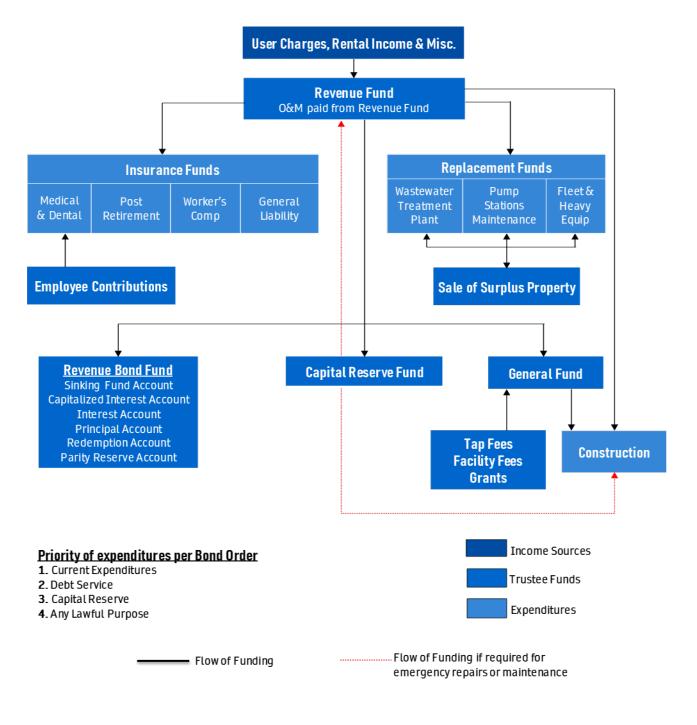
### Recommendation
