BOARD OF THE METROPOLITAN SEWERAGE DISTRICT October 15, 2025

1. Call to Order and Roll Call:

The regular monthly meeting of the Metropolitan Sewerage District Board was held in the Boardroom of MSD's Administration Building at 2:00 pm, Wednesday, October 15, 2025. Chairman Vehaun presided with the following members present: Ashley, Bryson, Dearth, Lapsley, Manheimer, Player, Tarleton, Watts, Wisler, and Whitesides. Moore, Pelly, and Pennington were absent.

Others present were William Clarke, General Counsel; Forrest Westall, PE, McGill Associates; Drew West with CIBO; Hunter Carson, Scott Powell, Mike Stamey, Derrick Swing, Darin Prosser, Wesley Banner, Spencer Nay and Pam Nolan, MSD.

2. Inquiry as to Conflict of Interest:

Mr. VeHaun asked if there were any conflicts of interest with the agenda items. No conflicts were reported.

3. Approval of Minutes of the September 17, 2025 Board Meeting:

Mr. VeHaun asked if there were any changes to the Minutes of the September 17, 2025 Board Meeting. Mr. Ashley moved for approval of the minutes as presented. Mr. Whitesides seconded the motion. Voice vote in favor of the motion was unanimous.

4. Discussion and Adjustment of Agenda: None.

5. Introduction of Guests:

Mr. VeHaun welcomed Drew West with CIBO.

6. Informal Discussion and Public Comment: None.

7. Report of Committees:

a. Planning Committee – October 10, 2025.

Mr. Carson reported that the Planning Committee met on Friday, October 10, 2025 at 9 am to discuss a developer appeal. MSD does not allow private pump stations and force mains to serve subdivided, separately owned parcels. KLP Pinners EAT, LLC, the Developer, proposed a solution that they feel addresses MSD's concern and meets the spirit of MSD's Policy. The Planning Committee called for a motion to continue discussion amongst the full Board at the November 19th Board Meeting and all were in favor. Between now and that time those meeting minutes will be passed out to this Board so that everyone may be prepared for that discussion.

8. Report of General Manager:

Mr. Carson reported that Tom Hartye is not at this meeting because he will be having surgery today for a new knee replacement and asked that everyone be thinking of him.

Mr. Carson reported that MSD's Grayson Hensley and Josh Matthews just returned from the Utility Expo in Louisville, Kentucky. They took part in the Hyundai Equipment Excavator Challenge which is a series of events using an excavator. There were about 70 contestants at this event. Grayson Hensley came in First place and Josh Matthews came in Third place. This is a testament to the talent we have here at MSD. Congratulations to both of them.

Mr. Carson reported that there are articles attached from the Watch Dog and Citizen Times regarding the ongoing construction of the Carrier Bridge Pump Station River Crossings. He presented photos of the construction of the coffer dam, excavation, and the force mains that are now installed roughly halfway across the river. These are anchored into bedrock for security and encased in concrete. The deconstruction of the coffer dam will now begin and a second cofferdam will be constructed on the opposite side of the river. Mr. Ashley asked if the concrete over the pipes was at the bottom of the river. Mr. Carson stated that they had to leave approximately a foot for native material to be placed over the top of the concrete, so it is not flush with the base of the riverbed.

Mr. Carson reported that the System Performance Annual Report (SPAR) is now updated on the MSD website. Thanks to Bart Farmer and Angel Reece for putting this together.

Mr. Carson reported that the next Right of Way Committee meeting will be held on October 22, 2025 at 9 am. The next regular Board Meeting will be held on November 19th at 2 pm.

9. Consolidated Motion Agenda:

a. Consideration of Bids – Montford Avenue @ Montford Park:

Mr. Carson reported that this project is located in Asheville near Montford Park. It is comprised of 804 LF of 8-inch DIP (installed by dig and replace) and 325 LF of HDPE (installed by pipe bursting). The existing clay pipe is in poor condition and has experienced SSO's. The project was advertised formally and no bids were received on September 25, 2025. The project was re-advertised and one bid was received on October 2, 2025, as follows: Terry Brothers Construction Company with a bid amount of \$645,430.00. Terry Brothers Construction Company has extensive experience with District rehabilitation projects and continues to provide excellent workmanship. The FY 25-26 construction budget for this project is \$590,000.00. Sufficient funds are available in the CIP contingency fund to cover the overage of \$55,430.00. Staff recommends award of this contract to Terry Brothers Construction Company in the amount of \$645,430.00, contingent upon review and approval by District Counsel.

b. Consideration of Bids - Intermediate Clarifier Trough Rehabilitation Phase2:

Mr. Carson reported that the intermediate clarifiers were placed into service in 1990. Clarified water flows upward through one of the four clarifier basins and overflows into a series of aluminum effluent troughs. As water passes upwards, the solids settle to the bottom of the basin, which are then collected by a chain and flight system which are fiberglass boards on a chain driven system that brings all of the solids to a sump. The troughs are in poor condition and are leaking due to significant corrosion, while the chains, flights and other underdeck equipment need replacement due to wear during operation. This is a phased project with Phase 1 being completed several months ago. Because of long lead times Staff pre-purchased some of the equipment which was the chain and flight system. This Phase 2 Contract is for the purchase of the fiber-reinforced polymer effluent troughs and installation of troughs and chain and flight system. Phase 2 of this project was advertised formally and one bid was received on August 28, 2025. Per General Statutes, the project was re-advertised and one bid was received on September 4, 2025, as follows: Cove Utility LLC with a bid amount of \$4,116,000.00. Cove Utility was the chosen contractor for Phase 1 of this project and has experience with other similar projects. The bid amount exceeds the funds available for this phase of the project. Per Statutes, District staff negotiated a reduction in the scope to bring the contract price within the budget for this phase. A copy of the reduced scope proposal is attached. The remaining work will be re-budgeted and bid in FY 26-27 as Phase 3 of this project. The construction budget for this phase is \$3,100,000.00, spread over two fiscal years. The construction budget includes \$831,900.00 for the purchase of the underdeck equipment, leaving \$2,268,100.00 for this contract. The negotiated price of \$1,464,000.00 is within the budget for this phase. Staff recommends award of the contract to Cove Utility, LLC in the amount of \$1,464,000.00 and approval of the attached Capital Project Ordinance, contingent upon review and approval by District Counsel.

c. Consideration of Bids – Incinerator Rehabilitation Sludge Hauling Contract:

Mr. Carson reported that the Fluidized Bed Incinerator (FBI) at MSD's Water Reclamation Facility is the District's primary means of solids disposal. Originally placed into service in 1992, the FBI has undergone multiple component rebuilds. Next week a shutdown is scheduled to begin a major internal rehabilitation. The FBI rehabilitation contract was awarded by the MSD Board on September 17, 2025. This contract is for hauling of biosolids to the Buncombe County Landfill during the rehabilitation period. The contract is based on a per-load cost for approximately 20 weeks, with an estimated total of 1,160 loads. Hauling operations will be performed using six dump trucks, operating six days per week while the landfill is open. Trucks will remain on-site until the rehabilitation is complete and the FBI is fully operational. The project was formally advertised and one bid was received on September 19, 2025. Per General Statutes, the project was re-advertised and three bids were received on September 26, 2025 as follows: J&A CCM, LLC with a bid amount of \$763,036.40; TransMountain Industries with a bid amount of \$742,400.00 and Carroll Gentry Hauling with a

bid amount of \$503,440.00. The apparent low bidder is Carroll Gentry Hauling with a bid amount of \$503,440.00. This will be Carroll Gentry Hauling's first contract with the District. The vendor has prior experience providing material and debris hauling services for NCDOT. A reference check was initiated with the NCDOT. At the time this item was prepared for this meeting, Staff had received no response for reference checks. Those references have been received. One is from NCDOT. Carroll Gentry Hauling has done work for the NCDOT since 2008 with very favorable references. The second was a positive reference from LBM Industries. The FY 25-26 construction budget for the Incinerator Rehabilitation project is \$2,000,000.00 and includes sludge hauling. The Incinerator Rehabilitation construction contract was awarded in the amount of \$1,845,000.00, leaving \$155,000.00 available for sludge hauling, a deficiency of \$348,440.00. Sufficient funds are available in the CIP Contingency fund to cover the overage. Staff recommends award of this contract to Carroll Gentry Hauling in the amount of \$503,440.00, contingent upon review and approval by District Counsel.

d. Consideration of Developer Constructed Sewer Systems – 3927 Sweeten Creek (Rumi Way); Encore Townhomes Phase 1; Focus Homes (Mallard Run); Rockdale Development:

Mr. Carson reported that the 3927 Sweeten Creek (Rumi Way) project is located along Sweeten Creek Road in the City of Asheville and included extending approximately 590 linear feet of 8-inch public gravity sewer to serve 16 Single-Family residences.

Mr. Carson reported that the Encore Townhomes Phase 1 project is located along Reems Creek Road in Buncombe County and included extending approximately 1,563 linear feet of 8-inch public gravity sewer to serve 139 Single-Family residences.

Mr. Carson reported that the Focus Homes (Mallard Run) project is located along Mallard Run Drive in Buncombe County and included extending approximately 1,564 linear feet of 8-inch public gravity sewer to serve 50 Single-Family residences.

Mr. Carson reported that the Rockdale Subdivision project is located along Rockdale Avenue in Buncombe County and included extending approximately 630 linear feet of 8-inch public gravity sewer to serve 9 Single-Family residences.

All MSD requirements have been met. Staff recommends acceptance of the aforementioned developer constructed sewer system.

Mr. Lapsley asked if there was a rough number of the value of all of these extensions. Mr. Carson stated that each of those agenda items includes an estimated cost of \$78,425.00, \$210,000.00, \$150,000.00, and \$145,700.00. Mr. Lapsley stated that it was probably around \$1 million and that the public's perception is that the developers pay for this. He stated that the point he is trying to make is that the developer may pay for the initial cost but it is the consumer that ends up paying for it. He stated that it is his opinion that all of that cost just

plays into the cost of affordable housing. He stated that people lose sight of the fact that the developer doesn't lose money, the developer passes that cost on. He stated that he is confronted all of the time with his local government and county commissioners about the cost of affordable housing. He stated that he would submit that it is things like extension of sewer service, extension of water service, road construction, all of those things that are a cost to the developer in the beginning end up being cost to the buyer. He stated that he feels that it is incumbent on everyone's part to try to keep the cost of these utilities down to make housing affordable.

e. Cash Commitment Investment Report – Month ended August, 2025:

Mr. Powell reported that Page 35 presents the makeup of the District's Investment Portfolio. There has been no significant change in the makeup of the portfolio from the prior month. Page 36 presents the MSD Investment Manager's report as of the month of August. The weighted average maturity of the investment portfolio is 110 days. The yield to maturity is 4.29%. Page 37 presents the analysis of the District's Cash Receipts. Monthly and YTD domestic are considered reasonable based on timing of cash receipts and historical trends. Monthly and YTD Industrial User Fees as well as Facility and Tap Fees are considered reasonable based on timing of cash receipts and historical trends. Page 38 presents an analysis of the District's Expenditures. Monthly and YTD expenditures are considered reasonable taking into consideration the current year budget and historical trends. Page 39 presents MSD's Variable Debt Service report. The 2008A Series is performing at budgeted expectations. As of the end of September, the issue has saved the District's rate payers approximately \$8 Million in debt service since April, 2008.

With no further discussion, Mr. VeHaun called for a motion to approve the Consolidated Motion Agenda. Mr. Watts moved, Ms. Wisler seconded the motion. Roll call vote was as follows: 11 ayes; 0 Nays.

10. Old Business: None.

11. New Business:

Mr. Clarke reported that there has been negotiation and a proposed settlement of a condemnation case so this Board will need to go into a closed session so that they may discuss. Mr. VeHaun called for a motion to go into closed session at 2:25 pm. Mr. Whitesides moved, Mr. Watts seconded. Voice vote was unanimous.

Mr. Clarke reported that he and Wesley Banner participated in mediation of a condemnation case, MSD v. Regal Hospitality 20 CVS 1341-100 arising out of the Christian Creek Interceptor Replacement Project. During mediation, the parties discussed a proposed settlement of \$25,000. Mr. Clarke is seeking the Board's approval of that settlement. The board discussed the project briefly and the property involved. The Board then returned to open session.

Mr. Carson reported that the MSD Annual company picnic will be held on Thursday, September 18^{th.} Please stop by for some good food and entertainment.

Mr. Carson reported that the September Right of Way Committee meeting has been cancelled. The next Right of Way Committee meeting will be held on October 22, 2025 at 9 am. There is a Planning Committee scheduled for October 10, 2025 at 9 am. The next regular Board Meeting will be held on October 15th at 2 pm.

8. Consolidated Motion Agenda:

a. Consideration of Bids – Kimberly Avenue @ Sedley Avenue:

Mr. Carson reported that this project is located in north Asheville along Kimberly Avenue between Kimberly Knoll and Griffing Boulevard. The project totals 2,710 LF of 6-inch pipe. The new project will predominately be 8-inch HDPE to be installed via pipe bursting. The existing pipe is 6-inch vitrified clay in poor condition with structural defects, heavy root intrusion and misaligned joints which have led to sanitary sewer overflows in the past increases the likelihood of those in the future. The project was advertised formally and one bid was received on August 28, 2025. Per General Statutes the project was re-advertised and again only one bid was received on September 4, 2025, as follows: Terry Brothers Construction Company with a bid amount of \$965,866.00. Terry Brothers has an extensive record of working with MSD and they do great work. The FY 25-26 construction budget for this project is \$985,000.00. Staff recommends award of this contract to Terry Brothers Construction Company in the amount of \$965,866.00 subject to review and approval by District Counsel.

b. Consideration of Bids - MSD Fleet & Warehouse Resurfacing:

Mr. Carson reported that this project will include removing and replacing the asphalt and subgrade materials in the parking lot areas to the west of MSD's Fleet and Warehouse buildings. Flooding during Hurricane Helene degraded the subsurface conditions exacerbating surficial cracking and impacting the asphalt's ability to support the heavy truck and equipment loads it is subjected to daily. This project includes removal of the existing asphalt and approximately three feet of subgrade material which will be built back up with new drainage stone, geotextile fabric, road bond and asphalt. This is about a 46,000 square foot parking area and drive that will be replaced. The project was advertised formally and two bids were received on August 28, 2025. Per General Statutes, the project was re-advertised and two sealed bids were received on September 4, 2025, as follows: French Broad Paving, Inc. with a bid amount of \$1,110,426.75 and C&T Paving, LLC with a bid amount of \$964,904.00. The apparent low bidder is C&T Paving, LLC with a bid amount of \$964,904.00. C&T Paving has extensive experience with District projects, having completed the paving for numerous CIP projects and having been awarded MSD's Non-City of Asheville ROW Paving Restoration Contract in 2024 and 2025. The FY 25-26 construction budget for this project is \$1,500,000.00. MSD is seeking FEMA reimbursement for this project and that process is progressing well. Staff recommends award of this contract to C&T Paving LLC in the amount of \$96,904.00, subject to review and approval by District Counsel.

c. Consideration of Bids – Incinerator Rehabilitation:

Mr. Carson reported that the Fluidized Bed Incinerator (FBI) at MSD's Water Reclamation Facility is the District's primary means of solids disposal. Originally placed into service in 1992, the FBI has undergone multiple component rebuilds over the years, with the last major rehabilitation completed in 2004. In late October, 2025, a four-month shut down is scheduled to begin to allow for a major

> internal rehabilitation. The FBI replacement project will include replacement of the interior firebricks (dome floor, inner walls and corbel), installation of a castable refractory ceiling in lieu of the existing brick ceiling, replacement of the nickel alloy tuyeres in the dome floor, and replacement of various pipe penetrations through the FBI's steel shell. Due to long lead times, the firebricks and tuyeres were pre-purchased under separate contracts and were approved by the MSD Board on February 21, 2024 and January, 2025. All of the materials are now in MSD's possession, so we are ready to begin that work next month. This contract is for the installation of the materials and removal of the old materials. The project was formally advertised and one bid was received on August 28, 2025. Per General Statutes, the project was therefore re-advertised and one bid was received on September 4, 2025 as follows: Industrial Furnace Company, Inc. with a bid amount of \$1,845,000.00. Over approximately 10 years, MSD has done a handful of projects with Industrial Furnace Company and they have done exceptional work on each project. The FY 25-26 construction budget for this project is \$2,000,000.00. Staff recommends award of this contract to Industrial Furnace Company Inc. in the amount of \$1,845,000.00, subject to review and approval by District Counsel.

d. Consideration of Developer Constructed Sewer System – Creekside Community Offsite and Onsite Sewer Extension:

Mr. Carson reported that this project is located along Brevard Road in Buncombe County. The developers of the project are Ambach Communities, LLC and 2177 Brevard, LLC. The project included extending approximately 4,984 linear feet of 8-inch public gravity sewer to serve 252 Single-Family and 250 Multi-Family residences. The project has been approved for both MSD's Revenue Sharing and Developer-to-Developer Reimbursement Programs. All MSD requirements have been met. Staff recommends acceptance of the aforementioned developer constructed sewer system.

e. Consideration of Bids – Sodium Hypochlorite Contract FY 26:

Mr. Carson reported that the Water Reclamation Facility (WRF) is required to disinfect the effluent prior to discharge to the French Broad River. Liquid sodium hypochlorite is used for this purpose. On average, the WRF uses approximately 200,000 gallons per year. The project was formally advertised on August 25, 2025. On September 8, 2025 two bids were received, bids were emailed to five vendors and an advertisement placed in the Asheville-Citizen Times and posted to the MSD web site. Two bids were received on September 8, 2025. Because this is a purchase contract there is no minimum number of bids. JCI Jones was the lowest bidder at \$1.57/gallon or \$314,000.00 based on the unit quantity. This is lower than the current contract with JCI Jones which is \$1.68/gallon. JCI Jones has agreed to hold their price firm for the total year contract irrespective of market changes. Staff recommends the contract be awarded to JCI Jones at a unit price of \$1.57 per gallon with the option of extending the contract by one additional year if it is in the best interest of MSD to do so. This is subject to review and approval by District Counsel.

f. Cash Commitment Investment Report – Month ended July, 2025:

Mr. Powell reported that Page 31 presents the makeup of the District's Investment Portfolio. There has been no significant change in the makeup of the portfolio from the prior month. Page 32 presents the MSD Investment Manager's report as of the month of July. The weighted average maturity of the investment portfolio is 111 days. The yield to maturity is 4.29%. Page 33 presents the analysis of the District's Cash Receipts. Monthly and YTD domestic are considered reasonable based on timing of cash receipts. Monthly and Industrial User Fees are considered reasonable based on timing of cash receipts and historical trends. Monthly and YTD Facility and Tap fees are above historical trends due to the timing of various cash receipts from developers as well as these fees being budgeted conservatively. Page 34 presents an analysis of the District's Expenditures. O&M, Debt Service and Capital Project expenditures are considered reasonable based on timing of cash expenditures. Page 35 presents MSD's Variable Debt Service report. The 2008A Series Bonds are performing at budgeted expectations. As of the end of August, the issue has saved the District's rate payers approximately \$8 Million in debt service since April, 2008.

With no further discussion, Mr. VeHaun called for a motion to approve the Consolidated Motion Agenda. Mr. Watts moved, Ms. Bryson seconded the motion. Roll call vote was as follows: 10 ayes; 0 Nays.

The next Right of Way Committee meeting will be held on October 22 at 9am. The next Board Meeting will be November 19th at 2 pm.

Question: While riding the River Arts District Greenway recently, I noticed a new cofferdam in the French Broad River, across from where the dog park used to be. What's going on? My assumption, which is probably wrong, is that they are relocating the Amboy Road bridge from up river at the confluence of the Swannanoa and French Broad. What's the actual answer?

My answer: Give us one more big flood, and that Amboy Road bridge might just relocate itself.

Real answer: This is not a bridge relocation at all. Rather, it's actually two major projects the Metropolitan Sewerage District is taking on. They are pretty hard to miss, as it's tough to hide a cofferdam in the river.

MSD General Manager Tom Hartye said via email that the district has separated the work into two projects "for the sake of expediting the construction disturbance and facilitating the restoration of French Broad River Park and Carrier Park in the wake of Helene.

"The first portion is the 'Pipeline River Crossings' project consisting of two open cut river crossings to install new pipelines for the future," Hartye said. "Since this portion of the project will affect the central area of both parks, it was carved out and was awarded back in March."

Blasting to begin at riverfront park for sewer line

ASHEVILLE – Blasting will likely begin Sept. 22 for a new pipeline crossing underneath the French Broad River, part of a multimillion-dollar Metropolitan Sew-

erage District project.
In-water work at French Broad River Park began in
August. It is part of the \$105 million Carrier Bridge Pump Station project, which will replace MSD's largest pump station, built in 1966, which sits adjacent to the park

In part, it will result in two new sewer line river crossings at French Broad River and Carrier parks — with about five feet of "coverage" overtop the pipes, which will be encased in concrete and anchored to bedrock, MSD Director of Engineering Hunter Carson

told the Citizen Times Sept. 17.

The work has been timed to coincide with restoration efforts in the heavily Tropical Storm Helenedamaged areas.

Pipes will be built under the river using a cof-rdam — which creates a horseshoe-shaped enclosure in the water made of rock, earth and gravel. The area within is then drained and the line installed. A similar process is underway in Woodfin for the Taylor's Wave project.

The first cofferdam has been completed at French

Broad River Park. To install the new sewer lines, the contractor must dig a trench below the river, Carson

Beneath the soil and silt on the bottom of the French Broad, there is "extremely hard bedrock." It is too hard to remove using normal excavation or mechanical hammering, so blasting is the only "practical way" to break the rock into smaller, manageable

Traffic in and around the blasting area will be

stopped during each blast.

Boreholes created by a drilling rig are filled with controlled charges of explosives, such as gelatin dynamite, Carson said of the process. A detonator then sets off the charge. Nearby, people may hear warning signals followed by the muffled sound of the blast. Visually, it is designed to be uneventful. There will be no large explosions or flying debris, just the breaking apart of the rock so it can be excavated safely, he said.

French Broad River Park remains closed, as it has since Helene ravaged the riverside park, resulting in destruction of infrastructure, an area dog park and

As the MSD project continues, a section of the Wilma Dykeman Greenway on the east side of the river, from Foundy Street to Amboy Road, will be temporarily closed, with users rerouted to the sidewalk on the far side of Lyman Street. The closure is waik on the lar side of Lyman Street. In eclosure is expected to last about four months to allow staging of construction equipment and materials, and construction of the second cofferdam.

The southbound lane of Lyman Street will also require periodic temporary closures. In preparation

for the river crossing at Carrier Park, the contractor has begun staging materials at the west end of the park, as well.

The first river crossing is expected to be finished in mid-January, the Citizen Times reported in August. The timeline is subject to change based on rainfall and river elevation

When will French Broad parks be rebuilt?

In August, the city entered into a \$4.6 million contract with Boston-based firm Sasaki Associates to tract with Boston-based firm Sasaki Associates to provide design and engineering services needed to rebuild the French Broad riverfront park system. The firm is behind several resilient waterfront parks, like those in Cedar Rapids, Iowa; Wilkes-Barre,

Pennsylvania; and the Chicago Riverwalk, according to its statement of qualifications submitted to the

city.

Through the contract, Sasaki will provide a comprehensive recovery and enhancement design plan to rebuild, mitigate and improve Asheville's parks, greenways and open spaces along the French Broad, according to a staff report. The design phase will last through summer 2026.

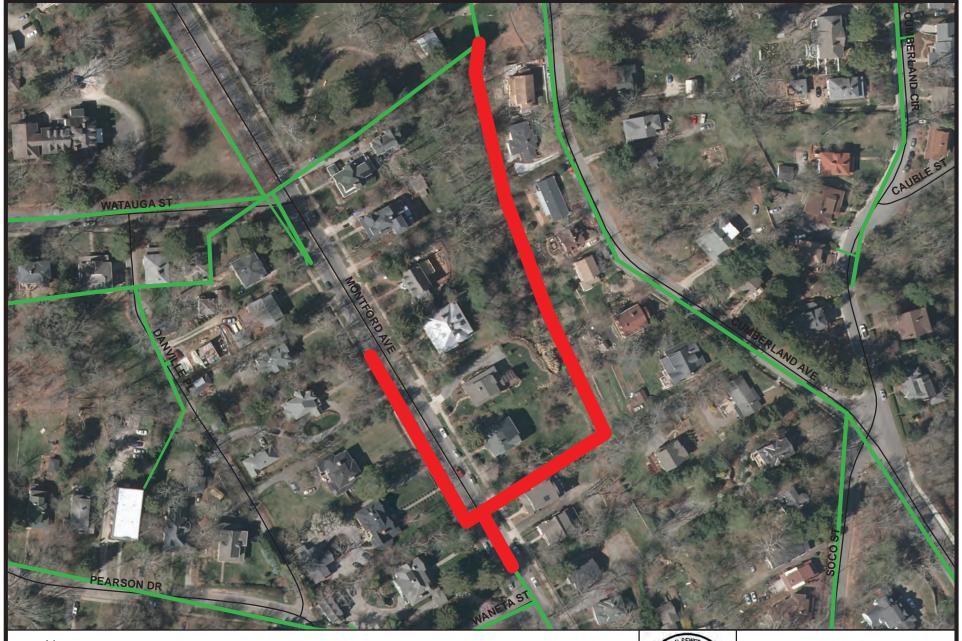

BACKGROUND:

The intermediate clarifier was placed into service in 1990. Clarified water flows upward through one of four clarifier basins and overflows into a series of aluminum effluent troughs, while solids settle out and are swept along the bottom of the basin by boards (flights) mounted on chains that run the length of the basin, which are in turn moved by gears near the center of the clarifier. The troughs are in poor condition and are leaking due to significant corrosion, while the chains, flights, and other underdeck equipment are in need of replacement due to wear during operation.

The intermediate clarifier rehabilitation project has been divided into multiple phases: Phase I, completed in Summer 2025, replaced effluent troughs and underdeck equipment in the southwestern basin of the intermediate clarifier. Phase II was designed to include the replacement of the same equipment in the southeast, northwest and northeast basins. The underdeck equipment was approved for sole source purchase in April 2025 and is currently being manufactured. This contract will be for the purchase of new fiber-reinforced polymer effluent troughs and installation of troughs and underdeck equipment by the selected contractor.

Phase 2 was advertised formally, and one bid was received on August 28, 2025. Per NCGS bidding requirements, the project was re-advertised, and one sealed bid was received on September 4, 2025, at 2:30 PM in the following amounts:

1) Cove Utility, LLC \$4,116,000.00

The apparent low bidder is Cove Utility, LLC with bid amount of \$4,116,000.00. Cove Utility was the chosen contractor for Phase 1 of this project and has experience with other similar projects.

The bid amount exceeds the funds available for this phase of the project. Per NCGS § 143-129 (b), District staff negotiated a reduction in scope to bring the contract price within the budget for this phase of the project. A copy of the reduced scope proposal is attached for reference. The remaining work will be re-budgeted and bid in FY 26-27 as Phase 3 of this project.

FISCAL IMPACT: The construction budget for this phase of the project is \$3,100,000.00, spread over two fiscal years. The construction budget includes \$831,900.00 for the purchase of the underdeck equipment, leaving \$2,268,100 for this contract. The negotiated price of \$1,464,000.00 is within the budget for this phase of the project.

STAFF RECOMMENDATION: Staff recommends award of the contract to Cove Utility, LLC in the amount of \$1,464,000.00 and the approval of the attached Capital Project Ordinance, contingent upon review and approval by District Counsel.

BACKGROUND: The Fluidized Bed Incinerator (FBI) at MSD's Water Reclamation Facility

serves as the District's primary method for solids disposal. Originally commissioned in 1992, the FBI has undergone multiple component rebuilds, with the last major rehabilitation completed in 2004. A four-month shutdown is scheduled to begin in late October 2025 to facilitate a major internal rehabilitation. The FBI rehabilitation contract was awarded by the

MSD Board on September 17, 2025.

This contract is for the hauling of biosolids to the Buncombe County Landfill during the rehabilitation period. The contract is based on a perload cost for approximately 20 weeks, with an estimated total of 1,160 loads. Hauling operations will be performed using six dump trucks, operating six days per week while the Landfill is open. Trucks will remain on-site until the rehabilitation is complete and the FBI is fully operational.

The incinerator rehabilitation sludge hauling contract was formally advertised, and one bid was received on September 19, 2025, at 2:00 p.m. In accordance with NCGS formal bidding requirements, the project was re-advertised. On September 26, 2025, at 2:00 p.m., three bids were received in the following amounts:

Metropolitan Sewerage District Variable Debt Service Report

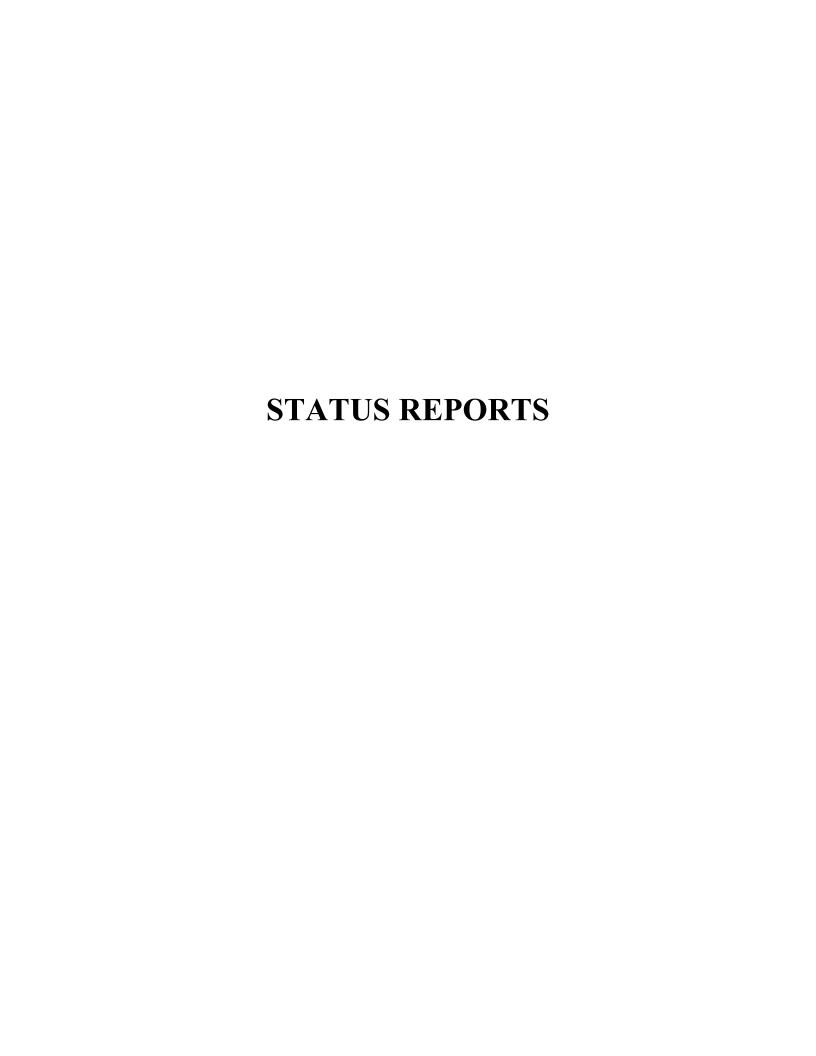
